Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective February 1, 2017?

Procedural History

On December 3, 2016, NY State of Health (NYSOH) issued an eligibility determination notice, based on your December 2, 2016 updated application, stating that you remained conditionally eligible for Medicaid, effective January 1, 2017. That notice also stated that you needed to provide proof of income by December 17, 2016.

On December 5, 2016, you submitted proof of your income to NYSOH, which was subsequently validated by NYSOH on December 20, 2016 (see Document [REDACTED]).

On December 21, 2016, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid, effective January 1, 2017.

On December 28, 2016, NYSOH issued a plan enrollment notice, based on your December 27, 2016 plan selection, confirming your enrollment in your Medicaid Managed Care plan effective February 1, 2017.

On January 25, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your Medicaid Managed Care plan insofar as it did not begin January 1, 2017.

On May 11, 2017, your spouse appeared on your behalf at a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) Your spouse testified that you are appealing only your eligibility.
- 2) You submitted an updated application to NYSOH for financial assistance on December 2, 2016. And were found conditionally eligible for Medicaid pending proof of income.
- 3) On December 5, 2016, you submitted your income tax return to NYSOH, which was subsequently validated by NYSOH on December 20, 2016 (see Document [REDACTED]). You were found eligible for Medicaid that day and could select a Medicaid Managed Care plan for enrollment.
- 4) According to your NYSOH account and your spouse's testimony, you selected your Medicaid Managed Care plan on December 27, 2016, and your enrollment start date was made effective on February 1, 2017.
- 5) According to your NYSOH account, you had health insurance coverage under Medicaid Fee-For-Service from January 1, 2017 through January 31, 2017.
- 6) Your spouse testified that you were a [REDACTED] and that he was told by a NYSOH representative that you would be able to visit your doctor in January 2017 and that your health insurance would be backdated. He testified that he paid for your doctor's visit up front, per the doctor's request, and would like to be reimbursed.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan was effective February 1, 2017.

According to your NYSOH account, you updated your application through NYSOH on December 2, 2016 and, on that date, were found conditionally eligible for Medicaid pending proof of income. On December 5, 2016, you submitted your income tax return to NYSOH, which was subsequently validated by NYSOH on December 20, 2016. You were found eligible for Medicaid that day and could select a Medicaid Managed Care plan for enrollment.

Your spouse testified, and the record reflects, that you selected your Medicaid Managed Care plan on December 27, 2016, and that your enrollment was effective on February 1, 2017. This was confirmed in a plan enrollment notice issued by NYSOH on December 28, 2016.

Although your spouse testified he was told by a NYSOH representative that your health insurance would be backdated to January 1, 2017, that contention is not a sufficient basis to backdate coverage in your Medicaid Managed Care plan as the law dictates otherwise.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

Since you selected a plan on December 27, 2016, your Medicaid Managed Care plan would properly begin the first day of the second month following December 2016, which is February 1, 2017.

Therefore, the December 28, 2016 plan enrollment notice stating that your enrollment in your Medicaid Managed Care plan was effective February 1, 2017, was correct and must be AFFIRMED.

Decision

The December 28, 2016 plan enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

You were eligible for Medicaid and had coverage under Medicaid Fee-For-Service as of January 1, 2017.

The effective date of your Medicaid Managed Care plan is February 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to U.S. Department of Health and Human Services or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the U.S. Department of Health and Human Services. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
