## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you and your spouse were eligible to enroll in the Essential Plan 2, effective March 1, 2017?

Did NY State of Health properly determine that you and your spouse were no longer eligible for Medicaid, as of February 28, 2017?

## Procedural History

On March 23, 2016, NY State of Health (NYSOH) received your updated application for financial assistance.

On March 24, 2016, NYSOH issued an eligibility determination based on the March 23, 2016 application, stating that you and your spouse were eligible for Medicaid effective March 1, 2016.

On March 24, 2016, you enrolled yourself and your spouse in a Medicaid Managed Care plan with a start date of May 1, 2016.

On January 5, 2017, a renewal notice was issued by NYSOH stating you and your spouse could not enroll you in your current health plan for the next coverage year. The notice stated you and your spouse were enrolled into an Essential Plan 2 effective March 1, 2017. The notice stated you and your spouse were now eligible for the Essential Plan 2 with no monthly premium because federal and state data sources show your income was between \$22,108.00 and \$24,030.00.

On January 18, 2017, NYSOH issued an enrollment notice confirming you and your spouse were enrolled in an Essential Plan 2 with a start date of March 1, 2017.

On January 26, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of the eligibility determination that you and your spouse were no longer eligible for Medicaid effective February 28, 2017.

On April 20, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit with the aid of Urdu Interpreter [REDACTED]. The record was developed during the hearing and kept open 15 days for you to provide income documentation showing four weeks of paystubs or a letter showing your gross wages for the month of January, 2017.

As of the close of the record on May 5, 2017, NYSOH's Appeals Unit did not receive the requested information, and will therefore only consider the information provided in the record at the time of your telephone hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly. You will claim no dependents on that tax return.
- 2) You are seeking insurance through Medicaid for yourself and your spouse.
- 3) You testified you do not want to be eligible for the Essential Plan 2, because it was determined you would have to pay a premium amount for vision and dental.
- 4) You testified your only source of income is your employment.
- 5) You are paid weekly.
- 6) You receive \$9.25 per hour for approximately 40 hours a week.
- 7) NYSOH redetermined your household's eligibility based on federal and state data sources on January 4, 2017.
- 8) You testified the amount of \$22,700.00 "sounded correct."
- 9) Your application states that you will not be taking any deductions on your 2017 tax return.

10) Your application states that you live in Queens County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

## Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4).

On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you and your spouse were eligible for the Essential Plan 2, effective March 1, 2017.

NYSOH redetermined your household's eligibility based on federal and state data sources on January 4, 2017. On January 5, 2017, a renewal notice was issued stating that you and your spouse were now eligible for the Essential Plan 2 with no monthly premium because federal and state data sources show your income was between \$22,108.00 and \$24,030.00. You testified the annual household income amount of \$22,700.00 “sounded correct.”

You are in a two-person household. You expect to file your 2017 income taxes as married filing jointly and will claim no dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is between 138% and 200% of the Federal Poverty Level (FPL) for the applicable family size. On the date of your application, the relevant FPL was \$16,020.00 for a two-person household.

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution.

Since an annual household income of \$22,700.00 is 141.69% of the 2016 FPL, NYSOH properly found you and your spouse to be eligible for the Essential Plan 2 with a \$0.00 premium.

The second issue is whether NYSOH properly determined you and your spouse were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,020 for a two-person household. Since \$22,700.00 is 141.69% of the 2016 FPL, NYSOH properly found you and your spouse to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. The Hearing Officer left the record open for 15 days after your telephone hearing for you to provide proof of your monthly household income. As of the close of the record on May 5, 2017, NYSOH did not receive any documentation showing your current gross income for the month of January, 2017.

Since the January 5, 2017, renewal notice properly stated that you and your spouse were eligible for the Essential Plan 2, it was correct and is AFFIRMED.

## **Decision**

The January 5, 2017 renewal notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You and your spouse remain eligible for the Essential Plan 2.

You and your spouse were ineligible for Medicaid.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
