## NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On January 27, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to receive up to \$315.00 per month in advance payments of the premium tax credit, and eligible for cost-sharing reductions, effective March 1, 2017. You appealed this determination.

On June 2, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for July 5, 2017 at 10:00 AM.

On July 5, 2017, a Hearing Officer placed two calls to the telephone number that you provided to NYSOH, at 10:05 AM and 10:15 AM, but reached your voicemail. Also at 10:15 AM, the Hearing Officer attempted to reach you at the other telephone number in your account [REDACTED], but reached a voicemail that advised the caller to press “2” to speak to [REDACTED]. The Hearing Officer attempted to press “2”, but nothing happened. The Hearing Officer immediately called the number back and pressed “2” again, and the recording beeped, so the Hearing Officer left a voicemail. The Hearing Officer called the number on the hearing notice one final time at 10:35 AM, but was again unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

## **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
