Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your child's eligibility for and enrollment in Child Health Plus coverage ended effective January 31, 2017?

Procedural History

On October 6, 2016, your child was added to your NY State of Health (NYSOH) account and an application was submitted on her behalf. That day, a preliminary eligibility determination was prepared stating that your child was eligible to enroll in Child Health Plus and you selected a plan for her enrollment.

On October 7, 2016, NYSOH issued a plan enrollment notice confirming your child's enrollment in a Child Health Plus plan, effective November 1, 2016.

On October 10, 2016, NYSOH issued a notice of eligibility determination stating that your child was eligible to enroll in a full price Child Health Plus for a limited time, effective November 1, 2016. The notice directed you to provide documentation confirming her citizenship status and Social Security number before January 4, 2017.

On October 25, 2016, NYSOH issued a notice of eligibility determination, based on your October 24, 2016 application, stating that your child was eligible for a full price Child Health Plus for a limited time, effective December 1, 2016. This notice

directed you to provide documentation confirming her citizenship status and Social Security number before January 4, 2017.

Also on October 25, 2016, NYSOH issued a plan enrollment confirmation notice, based on your plan selection on October 24, 2016, confirming your child's enrollment in a full price Child Health Plus plan, effective November 1, 2016.

On December 20, 2016, NYSOH issued a notice of eligibility determination, based on your December 19, 2016 application, stating that your child was eligible for a full price Child Health Plus for a limited time, effective January 1, 2017. This notice directed you to provide documentation confirming her citizenship status and Social Security number before January 4, 2017.

Also on December 20, 2016, NYSOH issued a plan enrollment confirmation notice, based on your plan selection on December 19, 2016, confirming your child's enrollment in a full price Child Health Plus plan, effective November 1, 2016.

On January 11, 2017, NYSOH issued an eligibility determination notice stating that your child was not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. She also could not enroll in a qualified health plan at full cost because you had not confirmed her citizenship status and Social Security number within the required timeframe.

Also on January 11, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in her Child Health Plus plan would end effective January 31, 2017 because she was no longer eligible to enroll in health insurance through NYSOH.

On January 28, 2017, NYSOH received your updated application for financial assistance with health insurance. That day, a preliminary eligibility determination was prepared stating that your child was eligible for a Child Health Plus plan with \$60.00 monthly premium, effective March 1, 2017 and you selected a plan for her enrollment.

Also on January 28, 2017, you spoke to NYSOH's Account Review Unit and appealed your child's disenrollment from her Child Health Plus plan in the month of February 2017.

On January 29, 2017 NYSOH issued an eligibility determination notice based on the January 28, 2017 application, stating that your child was eligible to enroll in Child Health Plus with a \$60.00 monthly premium for a limited time, effective March 1, 2017. This notice requested that you provide documentation confirming her income by March 29, 2017, her proof of citizenship status, and her Social Security number by April 28, 2017.

Also on January 29, 2017, NYSOH issued a plan enrollment confirmation notice based on the plan selection you made on January 28, 2017, stating that your child was enrolled in a Child Health Plus plan with a \$60.00 monthly premium, effective March 1, 2017.

On April 25, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your child's disenrollment from her Child Health Plus plan for the month of February 2017.
- 2) The record indicates that your child was added to your NYSOH account on October 6, 2016. The application that was submitted that day indicates that she was a US Citizen but she did not have a Social Security number because you were in the process of applying for one.
- 3) The record indicates that on January 31, 2017 your child's Social Security number was added to your NYSOH account.
- 4) You testified that you did not know your child had been disenrolled from her Child Health Plus plan until you called to renew coverage for the 2017 insurance coverage year.
- 5) You testified that your child has unpaid medical bills for the month of February 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (PHL) § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(NY PHL § 2511(2)(a)-(e)).

As a condition of eligibility for Child Health Plus, an individual, including children, must furnish their Social Security number and evidence of their citizenship or status as a qualified immigrant or PRUCOL alien to NY State of Health for verification purposes (42 CFR § 435.910(a) and (b)(3); 42 CFR § 457.340(b); 18 NYCRR § 360-3.2(j)(2) and (3); *see generally* 18 NYCRR § 360-3.2(j)).

NYSOH must require an applicant who has a Social Security number to provide the number but does not require an applicant's Social Security number as a condition of enrollment for Child Health Plus if the applicant is not eligible to receive one or his or her number is not yet available (42 CFR § 457.340(b), 42 CFR § 435.910(h)(1); Model State Children's Health Insurance Program Plan, Section 4.1.9).

If an applicant attests to citizenship, status as a national, or lawful presence, and NYSOH is unable to verify such attestation, NY State of Health must then provide the applicant with 90 days to provide satisfactory documentary evidence. Notice is considered received five days after the date on the notice, unless the applicant demonstrates that he or she did not receive the notice within the five-day period (45 CFR § 155.315(c)(3), (f)(2)(i)).

If NYSOH remains unable to verify the citizenship attestation after the 90-day period ends, it must determine the applicant's eligibility based on the information available (45 CFR § 155.315(f)(5)).

NYSOH is required to provide proper written notice to an applicant of any decision effecting an enrollee's Child Health Plus eligibility (42 CFR § 457.340(e)). When Child Health Plus coverage is denied, suspended or terminated NYSOH must provide sufficient notice to enable the child's parent or caretaker relative to take appropriate actions to allow Child Health Plus coverage to continue without interruption (42 CFR § 457.340(e)(2); 42 CFR § 457.1130(a)(3)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (*see State*

Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child's eligibility for and enrollment in Child Health Plus terminated effective January 31, 2017.

NYSOH is required to determine whether individuals are eligible to enroll in coverage through NYSOH, and must confirm, among other things, their Social Security number and citizenship status.

If NYSOH cannot verify an individual's citizenship status or Social Security number, it must provide the individual with notice of the inconsistency. NYSOH must then provide the individual with a period of 90 days from the date notice is received to resolve the inconsistency.

The record indicates that your child was added to your NYSOH account on October 6, 2016. The application that was submitted that day indicates that she was a US Citizen but she did not have a Social Security number because you were in the process of applying for one.

In the eligibility determination issued on October 10, 2016, you were advised that your child's eligibility for Child Health Plus was only conditional, and that you needed to confirm her Social Security number and citizenship status before January 4, 2017.

The record indicates that you entered your child's Social Security number in your NYSOH account on January 31, 2017. The record also indicates that NYSOH did not have her Social Security number before the January 4, 2017 deadline.

On January 11, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in her Child Health Plus plan would end effective January 31, 2017 because she was no longer eligible to enroll in health insurance through NYSOH. According to the eligibility determination issued on that day, this was because NYSOH did not receive documentation of her citizenship status and Social Security number.

When NYSOH denies, terminates, or suspends a child's Child Health Plus coverage, they are required to provide sufficient notice so that a child's parent has the chance to prevent a gap in coverage for the child. Notice is considered received five days after the date on the notice. In this case, the notice formally disenrolling your child from her Child Health Plus plan was dated January 11,

2017. Therefore, the notice terminating your child's enrollment would be considered received as of January 16, 2017.

When changes are made to an individual's application after the 15th of any month, NYSOH must make the redetermination that results from a change effective the first day of the next following month. Since you would have received NYSOH's notice terminating your child's Child Health Plus eligibility after the 15th of the month, any changes you would have made to your account to prevent a gap in coverage would not have been effective until March 1, 2017.

Therefore, NYSOH failed to provide you with sufficient notice that would have allowed you to take action to prevent a gap in Child Health Plus coverage for your child for the month of February 2017 and therefore, the January 11, 2017 eligibility determination and disenrollment notices are RESCINDED.

Your case is being RETURNED to NYSOH to reinstate your child into her Child Health Plus plan for the month of February 2017, and to notify you accordingly.

Decision

The January 11, 2017 eligibility determination and disenrollment notices are RESCINDED.

Your case is RETURNED to NYSOH to reinstate your child into her Child Health Plus plan for the months of February 2017, and to notify you accordingly.

How this Decision Affects Your Eligibility

Your child's coverage with her Child Health Plus plan should not have been terminated in February 2017 for failure to submit proof of her citizenship status and Social Security number.

Your case is being sent back to NYSOH to reinstate your child into her Child Health Plus for the months of February 2017, and to notify you accordingly.

This Decision has no effect on any subsequent eligibility determinations made by NYSOH.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
