## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On January 27, 2017, NY State of Health (NYSOH) issued a notice stating that the income information in your application does not match what NYSOH received from state and federal data sources. The notice requested that you additional income documentation to confirm your eligibility.

On January 30, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as NYSOH not issuing a timely notice of eligibility determination.

On March 21, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 26, 2017 at 1:00 pm.

On April 26, 2017, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you using the telephone number that you provided to NYSOH between 1:00 pm and 1:30 pm. However, there was no answer. Accordingly, we were unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
