NOTICE OF DISMISSAL – UNTIMELY APPEAL REQUEST

On November 12, 2016, New York State of Health (NYSOH) issued an eligibility determination notice stating in part that you and your spouse remained eligible for Medicaid, effective November 1, 2016.

Also on November 12, 2016, New York State of Health (NYSOH) issued a plan enrollment stating in part that your and your spouse’s enrollment in the Medicaid Managed Care plan you selected would start December 1, 2016.

The record indicates that you requested an appeal on January 30, 2017 insofar as your and your spouse’s enrollment in your Medicaid Managed Care plan did not begin until December 1, 2016. It is noted that at no time was a formal complaint in this regard filed with NYSOH.

Why Your Appeal Request Is Not Valid

Applicants and enrollees must request a hearing within sixty (60) days from the date of notice of their eligibility determination by NYSOH (45 CFR § 155.520(b)(2); 18 NYCRR § 358-3.5(b)(1)).

For an appeal to have been valid on the issue of your and your spouse’s enrollment in a Medicaid Managed Care plan as of December 1, 2016, as

addressed in the November 12, 2016 plan enrollment notice, an appeal should have been filed by January 11, 2017. According to the credible evidence in the record, a formal appeal was not filed until January 30, 2017, 2017, which date exceeds 60 days from the November 12, 2016 plan enrollment notice.

Therefore, your appeal request of the November 12, 2016 plan enrollment notice was not timely, and your appeal on the issue of the start date of your and your spouse's enrollment in your Medicaid Managed Care plan as of December 1, 2016, is DISMISSED.

How does this Dismissal Affect Your Eligibility?

This decision does not change your and your spouse's eligibility for or enrollment in health insurance through NYSOH.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. In that writing, you must explain why you think this dismissal should be vacated.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
