NOTICE OF DISMISSAL

On February 16, 2017, NY State of Health (NYSOH) issued an enrollment notice, stating that the Essential Plan coverage for you and your spouse would begin effective March 1, 2017. You appealed insofar as you were seeking an Essential Plan coverage start date no later than February 1, 2017.

On March 21, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 26, 2017, at 9:00 a.m.

A Hearing Officer called you at 9:00 a.m. on April 26, 2017. You answered the call and stated that you no longer wanted to proceed with the hearing since you and your spouse did not incur any medical bills during the month of February 2017. The Hearing Officer asked to swear you to obtain your sworn testimony for a formal withdrawal. You stated that you did not have the time to provide sworn testimony since you were on your way to work, and to just cancel the hearing.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
