On January 20, 2017, NY State of Health (NYSOH) issued a plan disenrollment notice, stating that you were disenrolled from your Medicaid Managed Care plan, effective January 31, 2017. You appealed this determination.

On March 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 25, 2017, at 9:00 a.m.

On April 3, 2017, NYOSH issued a Notice of Hearing Cancellation stating that your hearing that was scheduled for April 25, 2017 was canceled because you withdrew your appeal.

On April 5, 2017, NYOSH issued a Notice of Hearing to advise you that the hearing you requested was rescheduled for May 10, 2017 at 11:00 a.m.

On May 10, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 11:00 a.m., 11:15 a.m., and 11:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
