NOTICE OF DISMISSAL – FAILURE TO APPEAR

On January 25, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your children were eligible for Child Health Plus, effective March 1, 2017. You appealed this determination.

On April 6, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 4, 2017, at 9:00 a.m.

On May 4, 2017, a Hearing Officer attempted to call you at the telephone number that you provided to NYSOH at 9:00 a.m., 9:01 a.m., 9:02 a.m., 9:03 a.m. and 9:11 a.m., but the phone number you provided, [REDACTED] was not in service. Please contact NYSOH immediately and update your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
