#### Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you do not qualify to enroll in a qualified health plan outside of the open enrollment period?

## **Procedural History**

On October 25, 2016, NY State of Health (NYSOH) received your application for health insurance.

On October 26, 2016, NYSOH issued an eligibility determination notice stating that you were eligible for the Essential Plan for a limited time, effective December 1, 2016. It further stated that you need to submit household income documentation by January 23, 2017 to confirm your eligibility.

On November 3, 2016, NYSOH issued a plan enrollment notice confirming your enrollment, based on the selection you made on October 25, 2016, in an Essential Plan with a \$20.00 monthly premium, effective December 1, 2016.

On December 14, 2016, NYSOH issued a disenrollment notice confirming that you were disenrolled from your Essential Plan, effective December 1, 2016. The notice further stated that your coverage was ending because you failed to pay your insurance bill by the payment deadline.

No income documentation was received by NYSOH by January 23, 2017.

On January 30, 2017, NYSOH issued an eligibility determination notice stating that you were newly eligible for a full price qualified health plan, effective March 1, 2017. It further stated that this was because you had failed to submit income documentation by the deadline and NYSOH could not determine if you were eligible for help paying for health insurance without this information.

On February 1, 2017, NYSOH received your updated application for health insurance.

On February 2, 2017, NYSOH issued an eligibility determination, based on your February 1, 2017 application, stating that you were eligible for up to \$33.00 per month in advanced premium tax credits (APTC) for a limited time, effective March 1, 2017. Also on this date, you attempted to enroll into a qualified health plan, but were unable to.

Also on February 2, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as you were not eligible to enroll in a health plan outside of the open enrollment period.

On February 3, 2017, NYSOH issued a notice to confirm your appeal request from the previous day.

On May 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the record was closed after the hearing.

# **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the denial of a special enrollment period to enroll into a health plan through NYSOH.
- 2) On October 25, 2016, you submitted an application for health insurance and were found eligible for the Essential Plan for a limited time.
- You were enrolled in an Essential Plan, effective December 1, 2016.
- 4) You were disenrolled from your Essential Plan, effective December 1, 2016, due to nonpayment of premiums.
- 5) You testified that you did not know you were without insurance until you went into the hospital in February 2017 and were told that there was a problem with your health insurance.

- 6) On February 1, 2017 you submitted an updated application for health insurance.
- 7) You testified that you attempted to enroll in a qualified health plan on February 1, 2017, but were unable to do so.
- 8) Your application on February 1, 2017 states that you were seeking a special enrollment period because you were already eligible or an enrolled member and you recently became eligible for APTC.
- 9) You testified that since filing your application on February 1, 2017 there have been no other major changes to your household.
- 10) You testified that you did not rely on any statements made by NYSOH that prevented you in enrolling in a qualified health plan sooner.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

#### De Novo Review

NYSOH Appeals Unit must review each appeal de novo and "consider all relevant facts and evidence adduced during the appeals process" (45 CFR § 155.535(f)). "De novo review means a review of an appeal without deference to prior decisions in the case" (45 CFR § 155.500).

#### Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

#### Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
  - (i) Loses minimum essential coverage.
  - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
  - (iii) Loses pregnancy-related coverage.
  - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.
- (2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.
  - (ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.
- (3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.
- (4) The qualified individual's or his or her dependent's, enrollment or nonenrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.
- (5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;
- (6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

- (7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—
  - (i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or
  - (ii) Was living outside of the United States or in a United States territory at the time of the permanent move;
- (8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.
- (9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;
- (10) A qualified individual or enrollee—
  - (i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or
  - (ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;
- (11) A qualified individual or dependent—
  - (i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or
  - (ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;
- (12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan

benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

## Legal Analysis

The issue under review is whether NYSOH properly denied you a special enrollment period.

On February 2, 2017, you spoke to NYSOH's Account Review Unit and requested to be permitted to reenroll into a health plan for the remainder of 2017. The record does not contain a notice of eligibility determination on the issue of special enrollment period. It does contain a February 2, 2017 incident # which indicates that you are seeking to reenroll in a qualified health plan outside of the open enrollment period.

Here, the lack of a notice of eligibility determination on the issue of special enrollment periods does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue a notice of eligibility determination.

The text of incident # which acknowledges that you were seeking to be able to reenroll in a plan for the remainder of 2017, permits an inference that NYSOH did deny your special enrollment request.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the notice of eligibility determination had it been issued. Therefore, the issue under review is whether you were properly denied the ability to enroll in a qualified health plan outside of the open enrollment period for 2017.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another

health plan offered through NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

The record reflects that on December 14, 2016, NYSOH issued a disenrollment notice stating that your insurance with MetroHealth Care was cancelled effective December 1, 2016, because a premium payment had not been received in the proper timeframe.

The record reflects that you did not update your NYSOH account until February 1, 2017, in order to be reenrolled in a health insurance plan, which was out of the open enrollment period for 2017.

Generally, the loss of health insurance coverage is considered a triggering event. Here, your enrollment was terminated effective December 1, 2016, because the health plan did not receive the health insurance premiums in a timely manner. NYSOH considers the failure to pay premiums a voluntary action causing the termination of your coverage; therefore, you would not be entitled to a special enrollment period in which to enroll in new coverage on this basis.

The credible evidence of record indicates that no other triggering events has occurred that would qualify you for a special enrollment period.

Therefore, NYSOH properly denied you a special enrollment period.

#### **Decision**

NYSOH's denial of a special enrollment period to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

# **How this Decision Affects Your Eligibility**

You do not qualify for a special enrollment period at this time.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
