Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were enrolled in a Medicaid Managed Care (MMC) plan with an enrollment start date of March 1, 2017?

Procedural History

On January 4, 2017, you submitted an application for financial assistance through NYSOH.

On January 5, 2017, NYSOH issued a notice stating in part that the income information in your application did not match what NYSOH received from state and federal data sources and more information was needed to confirm the information in your application. The notice directed you to submit income documentation by January 19, 2017.

Also on January 5, 2017, NYSOH issued a disenrollment notice stating that your MMC plan then in place would terminate effective January 31, 2017.

On January 17, 2017, you uploaded additional income documentation to your NYSOH account ([REDACTED]).

On January 24, 2017, your account was systematically updated.

On January 25, 2017, NYSOH issued an eligibility determination notice stating in part that you were eligible for Medicaid effective as of February 1, 2017.

On February 1, 2017, NYSOH issued an enrollment notice confirming in part that, on January 31, 2017, you enrolled in a MMC plan with an enrollment start date of March 1, 2017.

On February 2, 2017, you spoke to NYSOH's Account Review Unit and requested an appeal of the March 1, 2017 enrollment start date of your MMC plan.

On May 2, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing and the record was closed at the end of the proceeding.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account, you renewed your application for financial assistance on January 4, 2017.
- 2) On January 17, 2017, you uploaded a letter from your spouse's employer stating that he receives an annual salary of \$40,000.00 (see Document [REDACTED]).
- 3) According to your NYSOH account, this documentation was validated on January 24, 2017.
- 4) According to your NYSOH account, you enrolled in a MMC plan on January 31, 2017.
- 5) You testified that you want your MMC plan to have an enrollment start date of February 1, 2017.
- 6) You testified that you incurred approximately \$130.00 in medical expenses in February 2017 and want the MMC plan to cover those costs.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid – Verification Process

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data that will allow NYSOH to verify the household's income (45 CFR §155.320(c)(1)(i), 42 CFR § 435.945).

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the opportunity to submit satisfactory documentary evidence (45 CFR §155.315(f) 42 CFR § 435.952).

MMC Enrollment Start Date

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your MMC plan should have an enrollment start date of March 1, 2017.

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data that will allow NYSOH to verify the household's income. If NYSOH cannot verify the income information required to determine eligibility, they must attempt to resolve the inconsistency by giving the applicant the opportunity to submit satisfactory documentary evidence.

On January 4, 2017, you submitted an application for financial assistance through NYSOH. The household income that you attested to in your application did not match federal and state data sources. As a result, NYSOH issued you a notice on January 5, 2017, directing you to submit additional of proof of income to NYSOH to confirm your eligibility for financial assistance.

On January 17, 2017, you uploaded a letter from your spouse's employer, stating that he receives an annual salary of \$40,000.00 (see Document [REDACTED]). On January 24, 2017, NYSOH determined that the documentation that was submitted was sufficient to confirm your attestation.

The record supports that the income documentation provided to NYSOH on January 17, 2017 was determined to be valid. Therefore, NYSOH had sufficient information to render an eligibility determination as of that date.

The date on which a MMC plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected an MMC plan on January 30, 2017, the enrollment start date must go into effect on the first day of the second month following January 2017; that is, as of March 1, 2017.

If you had selected a Medicaid Managed Care plan on January 17, 2017, the plan enrollment start date would still have been on the first day of the second month following January 17, 2017; that is, on March 1, 2017.

Therefore, the February 1, 2017 plan enrollment notice is AFFIRMED.

Decision

The February 1, 2017, enrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your MMC plan enrollment start date is March 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
