NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On February 1, 2017, NY State of Health (NYSOH) issued an enrollment notice, stating that your child Medicaid Managed Care (MMC) plan enrollment would begin effective March 1, 2017. You appealed insofar as you were seeking for your child's MMC plan coverage to begin no later than February 1, 2017.

On April 10, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 9, 2017, at 11:00 a.m.

On March 9, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 11:07 a.m. and 11:18 a.m. On the second call attempt, an individual answered and stated that you were not available. The Hearing Officer asked that individual if you would be available within the next half hour, or if there was an alternate number at which you could be reached. The individual stated that you would not be available, and there was no alternative number available for you. Accordingly, we could not reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
