NOTICE OF DISMISSAL – UNTIMELY APPEAL REQUEST

On April 17, 2016, NY State of Health (NYSOH) issued a disenrollment notice stating that your health insurance coverage with your Medicaid Managed Care plan would end April 30, 2016.

The record indicates the following (1) you were originally found eligible for Medicaid effective May 1, 2015 and were enrolled in a Medicaid Managed Care plan starting July 1, 2015; (2) on March 12, 2016, NYSOH issued a renewal notice stating that you needed to update your account by April 15, 2016; (3) no updates were made to your account by April 15, 2016; (4) on April 17, 2016 NYSOH issued a disenrollment notice stating your Medicaid Managed Care plan would end effective April 30, 2016 because you were no longer eligible for health insurance through NYSOH; (5) on February 6, 2017 you updated your NYSOH account and were determined eligible for the Essential Plan and enrolled in Essential Plan 1 with a \$20.00 monthly premium, effective March 1, 2017; (6) also on February 6, 2017 your filed a formal appeal regarding the April 17, 2016 disenrollment notice that ended your Medicaid Managed Care plan on April 30, 2016; and, (7) you did not have any medical treatment during the time you were without health insurance but are concerned about a tax penalty.

Why Your Appeal Request Is Not Valid

Individual applicants and enrollees must request a hearing within sixty (60) days of the date of their notice of eligibility determination by NYSOH (45 CFR § 155.520(b)(2); 18 NYCRR § 358-3.5(b)(1)).

For an appeal to have been valid on the issue of your Medicaid Managed Care end date, as addressed in the April 17, 2016 notice, an appeal should have been filed by June 16, 2016. According to the credible evidence in the record, you did not contact NYSOH until February 6, 2017 to update your account and filed a formal appeal at that time. February 6, 2017 is well beyond 60 days from the April 17, 2016 disenrollment notice.

Therefore, there has been no valid timely appeal of the April 17, 2016 disenrollment notice and your appeal on the issue of your Medicaid Managed Care end date as stated in the April 17, 2016 disenrollment notice is **DISMISSED**.

Sometimes after an appeal decision, an appellant can claim an exemption from the requirement to have health insurance. You might qualify for a health coverage exemption in 2016 if you didn't have health coverage while you were waiting for an appeal decision about coverage eligibility or savings **and** your appeal was eventually successful (emphasis added).

You must claim this exemption through the United States Department of Health and Human Services (HHS). Currently, NYSOH does not accept hardship exemption applications.

Important: If you do not get a response from HHS to your exemption application in time to file your tax return, write the word "pending" in column "c" and file your return. If HHS does not approve your exemption, you will need to file an amended return later.

How does this Dismissal Affect Your Eligibility?

This decision does not change your current eligibility for or enrollment in the Essential Plan.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. In that writing, you must explain why you think this dismissal should be vacated.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
