Issues

The issues presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you were eligible to enroll in the Essential Plan for a cost of \$20.00 per month effective March 1, 2017?

Did NY State of Health properly determine that you were not eligible for Medicaid, as of March 1, 2017?

Procedural History

On February 3, 2017, NYSOH received your updated application for financial assistance.

On February 4, 2017, NYSOH issued an eligibility determination based on the February 3, 2017 application, stating that you are eligible to enroll in the Essential Plan with a \$20.00 per month premium, effective March 1, 2017. The notice stated the income amount listed in your application was \$20,800.00.

On February 6, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination insofar as you were not eligible for a \$0.00 per month premium Essential Plan or Medicaid.

On June 15, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit with the aid of Spanish Interpreter [REDACTED]. The record was developed during the hearing and held open 15 days for you to provide

supporting documentation in the form of paystubs for the month of February, 2017.

On June 26, 2017, NYSOH Appeals Unit received a 5-page fax with your supporting documentation and has been incorporated into the record as (Appellant's Exhibit [REDACTED]). The record is now closed.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) You testified you are seeking a higher level of financial assistance or to be found eligible for Medicaid so that you do not have a premium responsibility.
- 4) The application that was submitted on February 3, 2017, which requested financial assistance, listed annual household income of \$20,800.00.
- 5) You provided income documentation in the form of four weeks of paystubs with check dates of February 3, 10, 17, 24, 2017, in the gross amounts of \$364.00, \$340.00, \$340.00, and \$410.00 respectively (See Appellant's Exhibit [REDACTED]).
- 6) Your application states that you will not be taking any deductions on your 2017 tax return.
- 7) The record supports after your February 6, 2017, request for an appeal hearing you were determined eligible for the Essential Plan 2 with a cost of \$0.00 per month starting June 1, 2017, and you enrolled in a plan with a \$31.86 per month premium responsibility due to selecting an additional vision and dental plan with your enrollment.
- 8) You testified your annual expected household income is closer to \$17,160.00 which you had submitted in an application to NYSOH on May 5, 2017.
- 9) Your application states that you live in [REDACTED].

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4).

On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan at a cost of \$20.00 per month, effective March 1, 2017.

The application that was submitted on February 3, 2017 listed an annual household income of \$20,800.00 and the eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is between 138% and 200% of the Federal Poverty Level (FPL) for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household.

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution.

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution.

Since an annual household income of \$20,800.00 is 175.08% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan 1 for a cost of \$20.00 per month effective March 1, 2017, based on the application submitted.

The second issue is whether NYSOH properly determined that you were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$20,800.00 is 172.47% of the 2017 FPL, NYSOH

properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You submitted four weeks of paystubs with check dates of February 3, 10, 17, 24, 2017, in the gross amounts of \$364.00, \$340.00, \$340.00, and \$410.00 respectively.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which at the time of your application was \$1,387.00 per month. Since the documentation you provided shows that you earned \$1,454.00 in the month of February, 2017 you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the February 4, 2017, eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan 1 for a cost of \$20.00 per month effective March 1, 2017, it was correct and is AFFIRMED.

Decision

The February 4, 2017 eligibility determination notice is AFFIRMED.

You were eligible for the Essential Plan 2 for a cost of \$20.00 per month effective March 1, 2017.

You were ineligible for Medicaid.

This decision has no effect on any subsequent applications or enrollments made after your February 4, 2017 eligibility determination notice.

This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
