NOTICE OF DISMISSAL – FAILURE TO APPEAR

On January 31, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in the Essential Plan for a limited time, effective March 1, 2017. The notice asked you to provide proof of your income by April 30, 2017. You appealed this determination.

On April 10, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 12, 2017, at 11:00 a.m.

On May 12, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 9:00 a.m., 9:15 a.m., and 9:30 a.m. The first two calls were placed to the number on the notice of hearing [REDACTED] but was unable to reach you, and messages were left. The third call was placed to your alternate number in your account [REDACTED]. The number was a work number and individual answered. The individual stated you were at lunch.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
