Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your spouse's enrollment in an Essential Plan was effective March 1, 2017?

Procedural History

On February 1, 2017, NY State of Health (NYSOH) issued an eligibility determination notice, based on your January 31, 2017 application, stating that your spouse was eligible to enroll in the Essential Plan, effective March 1, 2017.

Also on February 1, 2017, NYSOH issued a notice of enrollment, based on your plan selection for your spouse on January 31, 2017, stating that your spouse was enrolled in an Essential Plan with a start date of March 1, 2017.

On February 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your spouse's enrollment in the Essential Plan insofar as it did not begin January 1, 2017.

On May 15, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- According to your NYSOH account and your testimony, you submitted an application to NYSOH for financial assistance on behalf of your spouse on January 31, 2017. You enrolled her in an Essential Plan that day.
- 2) You testified that you wanted your spouse's enrollment in an Essential Plan to begin on January 1, 2017 because she has medical bills from January 2017.
- You testified that you would have submitted an earlier application for health insurance for your spouse if you had known she was eligible for coverage through NYSOH.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see https://www.medicaid.gov/basic-health-program/basic-health-program.html).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your spouse's enrollment in her Essential Plan was effective March 1, 2017.

You testified, and the record indicates, that you submitted your spouse's NYSOH application on January 31, 2017. As a result, she was found eligible for the Essential Plan as of March 1, 2017 and you selected for her and enrolled her into a plan that day with a March 1, 2017 start date.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On January 31, 2017, you selected an Essential Plan, so your spouse's enrollment properly took effect on the first day of the second month following January 2017; that is, on March 1, 2017.

Therefore, the February 1, 2017 eligibility determination and enrollment confirmation notices stating that your spouse's eligibility for and enrollment in the Essential Plan were effective March 1, 2017, are correct and must be AFFIRMED.

Decision

The February 1, 2017 eligibility determination and enrollment confirmation notices are AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your spouse's eligibility.

The effective date of your spouse's eligibility for and enrollment in the Essential Health Plan is March 1, 2017.

According to your NYSOH account, your spouse's enrollment in her Essential Plan was deleted on May 15, 2017 and will end effective May 31, 2017, since she and your family now reside in Massachusetts.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
