#### Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended effective October 31, 2016?

# **Procedural History**

On November 22, 2015, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium for a limited time, effective January 1, 2016. The notice further directed you to provide documentation confirming your income before February 17, 2016.

Also on November 22, 2015, NYSOH issued a notice confirming your enrollment in an Essential Plan, effective January 1, 2016.

On September 18, 2016, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective November 1, 2016.

Also on September 18, 2016, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of October 31, 2016, because you were no longer eligible to remain in your current health insurance.

On November 17, 2016, you updated your NYSOH account.

On November 18, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium for a limited time, effective November 1, 2016. The notice directed you to submit documentation of your income by February 15, 2017.

Also on November 18, 2016, NYSOH issued a notice of enrollment confirmation confirming your enrollment in an Essential Plan, effective January 1, 2017.

On February 6, 2017, you updated your NYSOH account.

On February 7, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, effective March 1, 2017.

Also on February 7, 2017, NYSOH issued a notice of enrollment confirmation confirming your enrollment in an Essential Plan, effective January 1, 2017.

On February 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the months of November and December 2016.

On May 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

# **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified, and your NYSOH account confirms, that you were enrolled to receive email alerts regarding notices in your NYSOH account at the time when the notices under appeal were issued.
- You testified that you received an email sometime in August or September 2016, but that you were unable to access the document, as it was encrypted and not viewable.
- 3) You testified that you have received some emails from NYSOH, but every time you tried to access a document in your NYSOH account, you had a problem viewing it.
- 4) You testified that you did not receive any notice from NYSOH in the mail stating that you had been disenrolled or that your coverage was going to end.

- 5) You testified that you did not know that there was any problem with your coverage until early November 2016, when you tried to fill a prescription and your coverage was not active.
- 6) You testified that you did not know what happened until you made a series of phone calls to NYSOH and were able to piece together that your coverage had been terminated.
- 7) You testified that you updated your account in November 2016, and you first submitted income documentation in February 2017, as that was when you received the statement of the Social Security benefit payments your spouse received in 2016.
- 8) Your account was updated again on February 6, 2017, and you were found eligible for the Essential Plan with no further documentation required.
- 9) You testified that you are now receiving documents from NYSOH by regular mail, as you asked to change your contact preferences after you found out that you had been disenrolled from coverage and had not received notices from NYSOH.
- 10) You testified that you are seeking reinstatement of your Essential Plan for the months of November and December 2016, as you had medical appointments during those months for which you incurred bills.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

# Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <a href="https://www.medicaid.gov/basic-health-program/basic-health-program.html">https://www.medicaid.gov/basic-health-program/basic-health-program.html</a>; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR §155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); see also 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); see also 42 CFR § 600.320(c)).

#### **Electronic Notices**

Applicants may choose to receive notices and information from NYSOH either by electronic alerts or by regular mail. If the applicant elects to receive electronic notices, NYSOH must send an email or other electronic communication alerting the individual that a notice has been posted to the applicant's account (42 CFR § 600.330(e); 42 CFR § 435.918(b)(4)).

Additionally, if an electronic alert regarding a notice in an individual's NYSOH account fails, NYSOH must send out the notice by regular mail within three days of the failed alert (42 CFR § 435.918(b)(5)).

# Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended effective October 31, 2016.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on November 22, 2015, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before February 17, 2016.

The record reflects that NYSOH did not receive the requested income documentation before the deadline.

However, you testified that you elected to receive alerts regarding notices from NYSOH electronically. You credibly testified that you received an email sometime in August or September 2016, but that you were not able to view the document to which it referred because it came up as encrypted. You testified that you therefore did not see the notice which advised you that your eligibility was only conditional and that you needed to submit documentation to confirm your income. You testified that you also did not receive this notice by mail.

Therefore, it is concluded that NYSOH did not give you the proper notice that you needed to submit documentation of your income in order to confirm your eligibility for the Essential Plan.

Since you were not made aware of and did not receive proper notice that there was an inconsistency in your NYSOH account, the September 18, 2016 eligibility determination and disenrollment notices, stating that you are no longer eligible for the Essential Plan because you failed to submit documentation, are RESCINDED.

Your case is RETURNED to NYSOH to reinstate your coverage in your Essential Plan for the months of November and December 2016.

# **Decision**

The September 18, 2016 notice of eligibility determination is RESCINDED.

The September 18, 2016 notice of disenrollment is RESCINEDED.

Your case is RETURNED to NYSOH to reinstate your coverage in your Essential Plan for the months of November and December 2016.

# **How this Decision Affects Your Eligibility**

NYSOH erred in terminating your Essential Plan effective October 31, 2016, without the proper notice.

Your case is being sent back to NYSOH to reinstate your coverage in your Essential Plan for the months of November and December 2016.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
