Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that you do not qualify to change your enrollment to a different qualified health plan outside of the open enrollment period?

Procedural History

On October 13, 2016, NY State of Health (NYSOH) issued a renewal notice stating that, based on federal and state data sources, NYSOH could not decide whether or not you qualified for financial help paying for your health insurance. This notice further directed you to update your account by December 15, 2016 so NYSOH could make an appropriate decision on your eligibility.

On November 27, 2016, NYSOH issued a disenrollment notice stating that your enrollment with your qualified health plan would end as of December 31, 2016.

No updates were made to your account by December 15, 2016.

On December 18, 2016, NYSOH ran an application on your behalf.

On December 19, 2016, NYSOH issued an eligibility determination notice stating that you were eligible to purchase a qualified health plan at full cost through NYSOH, effective January 1, 2017.

On January 12, 2017, NYSOH issued a plan enrollment notice confirming your enrollment in a gold-level qualified health plan, effective February 1, 2017.

On or around February 10, 2017, you attempted to change your enrollment into a different qualified health plan, but were unable to.

On February 10, 2017, you spoke to NYSOH's Account Review Unit and appealed insofar as you were not eligible to change your enrollment to another health plan outside of the open enrollment period.

On February 11, 2017, NYSOH issued a notice to confirm your appeal request from the previous day. That notice stated that the reason for your appeal was "Denial of Special Enrollment Period "SEP"."

On May 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing the denial of a special enrollment period to change your enrollment into a different health plan through NYSOH.
- 2) On January 11, 2017, you enrolled into a gold-level qualified health plan.
- 3) You testified that before enrolling into a qualified health plan that you utilized the NYSOH provider search tool to ensure that your doctor accepted the plan you selected.
- 4) You testified that it was important for you to make sure your doctor accepted your qualified health plan because you had been a patient of hers for many years.
- 5) You testified that you probably should have contacted your doctor's office before selecting a plan, but you solely relied on the information listed on the NYSOH website when selecting a qualified health plan for enrollment.
- 6) After review of the NYSOH search tool accessed from the NYSOH website, there is a disclaimer which states: "BUT, to be on the safe side, you should still ask your provider if they accept your health plan and participate in your network before receiving health care services or before enrolling in a health plan."

- 7) You testified that you were not aware that your doctor did not take your qualified health plan until about a week after open enrollment ended.
- 8) You further testified that your doctor's office informed you that they have had issues with the NYSOH website not updating their information to show the correct insurance plans she accepts.
- 9) You testified that since enrolling into your qualified health plan, there have been no other major changes to your household.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

De Novo Review

NYSOH Appeals Unit must review each appeal de novo and "consider all relevant facts and evidence adduced during the appeals process" (45 CFR § 155.535(f)). "De novo review means a review of an appeal without deference to prior decisions in the case" (45 CFR § 155.500).

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.

(ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.

(iii) Loses pregnancy-related coverage.

(iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.

(2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.

(ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

- (ii) Was living outside of the United States or in a United States territory at the time of the permanent move;
- (8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.
- (9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;
- (10) A qualified individual or enrollee—
 - (i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or
 - (ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;
- (11) A qualified individual or dependent—
 - (i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or
 - (ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;
- (12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or
- (13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance

affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you do not qualify to change your enrollment to a different qualified health plan outside of the open enrollment period.

You testified that you are appealing being denied a special enrollment period to enroll into a different health plan through NYSOH. However, the record does not contain a notice of eligibility determination or redetermination on the issue of special enrollment period.

Here, the lack of a notice of eligibility determination on the issue of special enrollment periods does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue a notice of eligibility determination as you are to appeal an adverse notice of eligibility determination. Your credible testimony, along with the February 11, 2017 appeal confirmation notice stating that the reason for your appeal was “Denial of Special Enrollment period “SEP,” permits an inference that NYSOH did deny your special enrollment request.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the eligibility determination notice had it been issued.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On January 11, 2017, you enrolled into a qualified health plan through NYSOH. You testified that, shortly after the open enrollment period ended, you were told that your long-time doctor did not accept the qualified health plan you are enrolled in. On or around February 10, 2017, you attempted to change your enrollment to a different qualified health plan, but were unable to do so.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period to enroll in, or change to another health

plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

A special enrollment period can be granted if a qualified individual's enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities

You testified that before you enrolled in a qualified health plan for the 2017 insurance year, you used the search tool on the NYSOH website to ensure that the qualified health plan you enrolled in was accepted by your doctor. However, shortly after open enrollment period ended, you were told that your long-time doctor did not accept the qualified health plan you were enrolled in, even though the NYSOH search tool indicated that they did. You further testified that you did not confirm with your doctor prior to enrolling into your qualified health plan and relied solely on the information listed on the NYSOH search tool.

However, the NYSOH search tool explicitly states that before enrolling into a qualified health plan, an individual should first check with their provider and not solely rely on the search results. Further, this misinformation did not prevent you from enrolling into a qualified health plan during open enrollment period. Therefore, it did not have any effect on your enrollment or non-enrollment into a qualified health plan during open enrollment period. As a result, this misinformation is not a triggering event that would qualify you for a special enrollment period.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you for a special enrollment period.

Therefore, NYSOH's denial of a special enrollment period to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

Decision

NYSOH's denial of a special enrollment period to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
