NOTICE OF DISMISSAL

On February 1, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your oldest child was no longer eligible for Medicaid, but that his Medicaid coverage would continue until November 30, 2017, effective March 1, 2017. You appealed this determination.

On April 13, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 18, 2017, at 1:00 pm.

A Hearing Officer called your authorized representative at 1:00 pm, 1:15 pm, and 1:30 pm and called you at 1:01 pm, 1:16 pm, and 1:31 pm on May 18, 2017. As your authorized representative was unavailable, you requested that your hearing be adjourned to a later date.

On May 19, 2017, a Hearing Officer called your authorized representative at 3:00 pm. Although your authorized representative answered the call, she stated that the hearing was no longer necessary as your oldest child is now enrolled in Child Health Plus, however, your authorized representative declined being sworn in.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
