NOTICE OF DISMISSAL – FAILURE TO APPEAR

On February 14, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for Medicaid coverage for the treatment of emergency medical conditions only. You appealed this determination.

On May 3, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for June 5, 2017, at 3:00 pm.

On June 5, 2017, a Hearing Officer attempted to call you at the telephone number listed on the hearing notice at 3:00 pm, 3:15 pm, and 3:30 pm, but the phone number listed on the hearing notice, [REDACTED] appears to be a fax line number, and may be a mistaken version of the phone number of the representative listed on your account.

However, the Hearing Officer could not call this representative directly at the number listed for that individual as no completed authorized representative designation form has been uploaded to your account.

Please contact NYSOH immediately and update your account. Should you wish to have an authorized representative appear on your behalf, you must submit an authorized representative designation form which may be found at <https://nystateofhealth.ny.gov/forms/DOH-5085.pdf>.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
