Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective March 1, 2017?

Procedural History

On December 2, 2016, NYSOH issued a notice of eligibility determination based on your December 1, 2016 application, stating you were eligible to enroll in the Essential Plan, effective January 1, 2017.

On December 2, 2016, NYSOH issued a notice of enrollment stating that you were enrolled in an Essential Plan as of January 1, 2017.

On February 2, 2017, NYSOH issued a notice of eligibility determination, based on your February 1, 2017 application, stating that you were eligible for Medicaid, effective February 1, 2017.

On February 2, 2017, NYSOH issued a disenrollment notice stating your Essential Plan would end February 28, 2017.

Also on February 4, 2017, NYSOH issued a notice of enrollment stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on March 1, 2017.

On February 15, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin February 1, 2017.

On May 24, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on December 1, 2016.
- 2) You testified your application counselor assisted you in your December 1, 2016 application submission.
- 3) You enrolled in an Essential Plan on December 1, 2016 with an effective date of January 1, 2017.
- 4) You testified you were not aware that you had a premium responsibility for the Essential Plan, and did not make the first January premium payment.
- 5) You testified you found out you were no longer enrolled in a plan until you went to a doctor visit.
- 6) You updated your application on February 1, 2017 and were found eligible for Medicaid.
- 7) You testified, and the record reflects, that you selected your Medicaid Managed Care Plan on February 3, 2017, and that your enrollment was effective on March 1, 2017.
- 8) You testified that you want your Medicaid Managed Care plan to begin on February 1, 2017 because you incurred medical bills for the month of February, 2017 which were not covered by Medicaid Fee for Service in the amount of approximately \$180.00.
- 9) You testified you contacted your health plan and were told you had been disenrolled from the Essential Plan for non-payment of premium.
- 10) The record supports there is no notice disenrolling you from your Essential Plan for non-payment of premium.

- 11) You receive your notices from NYSOH via regular U.S. mail.
- 12) You testified and confirmed your address has not changed in the past year.
- 13) You reside in New York County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13ADM-03(III)(F)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in the Medicaid Managed Care plan was effective March 1, 2017.

You submitted an application to NYSOH on December 1, 2016 with the aid of an application counselor. You were then determined eligible for the Essential Plan with a \$20.00 premium responsibility effective January 1, 2017. You then enrolled into a plan that day for a January 1, 2017 start date. You testified you did not pay the first month's premium payment for this plan.

You testified that you contacted NYSOH on February 1, 2017 and were found eligible for Medicaid for February, 2017. You then enrolled into a Medicaid Managed Care plan on February 3, 2017.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On February 3, 2017, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the month following February; that is, on March 1, 2017.

Therefore, the February 4, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective March 1, 2017, was correct and must be AFFIRMED.

Decision

The February 4, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

The effective date of your Medicaid Managed Care plan is March 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
