Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid as of March 1, 2017?

Procedural History

On March 25, 2016, NYSOH issued an eligibility determination stating that you were eligible for Medicaid, effective April 1, 2016.

On January 5, 2017, NYSOH issued a notice that it was time to renew your health insurance for the upcoming coverage year. That notice stated that based on information from federal and state sources, NYSOH could not determine whether you would qualify for financial help paying for your health coverage, and that you needed to update your account by February 15, 2017 or you might lose the financial assistance you were currently receiving.

On February 15, 2017, you submitted an updated application for financial assistance with NYSOH. Also on that date, NYSOH made a preliminary eligibility determination indicating that you were not eligible to purchase health care coverage through NYSOH.

Also on February 15, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of the preliminary eligibility determination insofar as you were not found eligible for Medicaid.

On February 16, 2017, NYSOH issued an eligibility redetermination notice stating that you were not eligible for Medicaid, Child Health Plus, Essential Plan, advance premium tax credits or to purchase a qualified health plan through NYSOH, effective March 1, 2017. The notice stated that you were ineligible because individuals enrolled in Medicare cannot receive health coverage through NYSOH.

On May 24, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are [REDACTED].
- 2) The record reflects and you testified that you receive, before any deductions, \$1,252.00 per month in SSA benefits.
- 3) You testified that you are currently enrolled in Medicare Part A and Part B and that you have been enrolled in Medicare since April 1, 2013.
- 4) You testified that you were seeking supplemental health insurance under Medicaid so that you can access medical coverage that is unavailable to you through Medicare.
- 5) You live in Richmond County, New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid Eligibility

An individual is eligible for enrollment in Medicaid through NYSOH (called MAGI-based Medicaid) when he or she meets certain nonfinancial criteria and has a household income that is at or below the applicable Medicaid income standard (45 CFR § 155.305(c); NY Social Services Law § 366(1)(b)).

Medicaid can be provided through NYSOH to adults who meet the following non-financial criteria: (1) Are age 19 or older and under age 65; (2) Are not pregnant; (3) Are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act; (4) Are not otherwise eligible for and enrolled for mandatory

coverage under a State's Medicaid State plan in accordance with subpart B of this part; and (5) Have a household modified adjusted gross income that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

If an individual does not fall into one of these categories, he or she may still be eligible for non-MAGI-based Medicaid coverage through their Local Department of Social Services or the New York City Human Resources Administration (see NY Social Services Law § 366(1)(c)).

Legal Analysis

The issue is whether NYSOH properly determined that you are not eligible for Medicaid, effective March 1, 2017.

To be eligible for MAGI-based Medicaid through NYSOH, a person cannot be entitled to or enrolled in Medicare Part A or B. You testified that you were enrolled in Medicare Part A and Part B since April 1, 2013. Therefore, you are not eligible for Medicaid through NYSOH and the February 16, 2017 eligibility determination is AFFIRMED.

NYSOH does not have the authority to decide if you qualify for non-MAGI-based Medicaid. Since you may be eligible for Medicaid on a non-MAGI basis, NYSOH will refer your case to the New York City Human Resources Administration (HRA) to determine your eligibility for Medicaid or other Medicare programs.

Decision

The February 16, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You do not qualify for Medicaid through NYSOH.

NYSOH does not have the authority to decide if you qualify for non-MAGI based Medicaid. Since you may be eligible for Medicaid on a non-MAGI basis, NYSOH will refer your case to your local department of social services office for consideration, if it has not already done so.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
