NOTICE OF DISMISSAL – FAILURE TO APPEAR

Dear [REDACTED],

On February 3, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for a full cost qualified health care plan, effective March 1, 2017. On March 7, 2017 NYSOH advised you that you were not qualified for a special enrollment period in which to change health care plans. You appealed both the February 3, 2017 determination and the March 7, 2017 verbal denial of a special enrollment period.

On April 17, 2017, NYSOH issued two separate Notices of Hearing to advise you that the hearings you requested were both scheduled for May 23, 2017, at 3:00 p.m.

On May 23, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 3:00 p.m., 3:10 p.m., and 3:25 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
