Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective March 1, 2017?

Procedural History

On January 5, 2017, NYSOH issued an eligibility determination notice, based on your January 4, 2017 initial application, stating that you were eligible for Medicaid effective February 1, 2017. That notice stated that you must pick a plan.

On January 10, 2017, NYSOH issued another eligibility determination notice stating that you remained eligible for Medicaid effective February 1, 2017. That notice also stated that you must pick a plan.

On January 27, 2017, NYSOH issued a plan enrollment notice, based on your January 26, 2017 plan selection, confirming you had selected a Medicaid Managed Care Plan and the effective date of that plan was March 1, 2017.

On February 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the enrollment notice insofar as your Medicaid Managed Care plan began on March 1, 2017, and not February 1, 2017.

On June 9, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on January 4, 2017.
- 2) You testified that because you had been auto-enrolled in the past, you did not know you needed to pick a plan.
- 3) You testified that you did not know that you needed to pick a plan until you received the January 5, 2017 and January 10, 2017 eligibility determination notices stating that you needed to select a plan.
- 4) According to your NYSOH account and your testimony, you selected your Medicaid Managed Care plan on January 26, 2017, and your enrollment was effective on March 1, 2017.
- 5) You testified that you want your Medicaid Managed Care plan to begin on February 1, 2017 because you had a procedure completed that month by a physician who does not accept Medicaid Fee-For Service as payment.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid Renewal

In general, NYSOH must review Medicaid eligibility once every twelve months or “whenever it receives information about a change in a beneficiary’s circumstances that may affect eligibility” (42 CFR § 435.916(a)(1), (d)). NYSOH must make its “redetermination of eligibility without requiring information from the individual if able to do so based on reliable information contained in the individual’s account or other more current information available to the agency, including but not limited to information accessed through any data bases accessed by the agency” (42 CFR § 435.916(a)(2)).

NYSOH must provide an individual with the annual redetermination notice, including the projected eligibility for coverage and financial assistance, and must require the qualified individual to report any changes within 30 days (45 CFR § 155.335(c), (e)). Once the 30-day period has lapsed, NYSOH must issue a redetermination as provided by the notice, with consideration given to any updates provided by the individual (45 CFR §155.335(h)).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Medicaid Managed Care (MMC) plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H(6)(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019, N.Y. Soc. Serv. Law §364-j(1)(c); 18 NYCRR § 360-10.3(h)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in your Medicaid Managed Care plan was effective March 1, 2017.

You were originally found eligible for Medicaid effective January 4, 2017. On January 5, 2017, NYSOH issued an eligibility determination notice stating that you were eligible for Medicaid effective February 1, 2017 and must pick a plan.

You testified that you received a letter stating that you must pick a plan. A notice is received five days after the date of that notice; therefore, it is concluded you received the January 5, 2017 notice on January 10, 2017. On January 26, 2017, you enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected after the fifteenth day of a month goes into effect on the first day of the second following month.

Since you selected your Medicaid Managed Care plan on January 26, 2017, it must take effect on the first day of the second month following January 2017; that is, on March 1, 2017.

Therefore, NYSOH's January 27, 2017 plan enrollment notice is **AFFIRMED** because it properly began your enrollment in your Medicaid Managed Care plan on March 1, 2017.

Decision

The January 27, 2017 plan enrollment notice is AFFIRMED.

Effective Date of this Decision: June 16, 2017

How this Decision Affects Your Eligibility

This decision does not change your eligibility. You were eligible for Medicaid Fee-For-Services, effective February 1, 2017.

The effective date of your Medicaid Managed Care plan is March 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
