Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did the NY State of Health (NYSOH) properly determine that your children's enrollment in their Child Health Plus plan was effective March 1, 2017?

Procedural History

On January 25, 2017, NYSOH issued a notice of eligibility determination, based on your January 23, 2017 application, stating that your children were eligible to enroll in Child Health Plus with a \$9.00 monthly premium, effective March 1, 2017.

Also on January 25, 2017 NYSOH issued a notice of enrollment, based on your plan selection on January 23, 2017, stating that your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start March 1, 2017.

On February 17, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin February 1, 2017.

On May 23, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and left open to allow the Hearing Officer time to review phone calls that you had with

NYSOH in January and February 2017. Five phone calls were reviewed and the record was closed.

Findings of Fact

A review of the record support the following findings of fact:

- 1) You testified that you are appealing your children's eligibility.
- 2) The record reflects that you started an online application on January 12, 2017, but did not complete and submit the application to NYSOH for financial assistance until you spoke with a representative on January 23, 2017.
- 3) You placed a call to NYSOH on January 23, 2017. During that call, you indicated that you had issues completing your application online and were seeking assistance. The representative completed your application and notified you that your prior coverage would end as of January 31, 2017. You enrolled your children in a Child Health Plus plan, and were advised that their coverage would begin effective March 1, 2017.
- 4) You placed a call to NYSOH on January 26, 2017 with the assistance of your certified application counselor, in order to transfer your application to the counselor's dashboard.
- 5) You placed a call to NYSOH on February 15, 2017. During that call you spoke with a representative and also with the Account Review Unit. You were advised that NYSOH could not backdate your children's Child Health Plus coverage, but that you could file an appeal.
- 6) You placed a call to NYSOH on February 17, 2017. During that call, you filed a formal appeal.
- 7) The record reflects that you enrolled your children into a Child Health Plus plan on January 23, 2017.
- 8) You testified that you need your children's Child Health Plus plan to begin on February 1, 2017 because you have outstanding bills for services rendered in February 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your children’s enrollment in their Child Health Plus plan was effective March 1, 2017.

You testified that you attempted to update your application online on January 12, 2017, but that you were unable to do so. You then contacted NYSOH by phone in order to complete the application. A review of the record shows that you called on January 23, 2017 and enrolled your children into a Child Health Plus plan that day.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected a plan for your children on January 23, 2017, NYSOH properly determined that the plan went into effect on the first day of the second following month, or March 1, 2017.

Therefore, the January 25, 2017 enrollment confirmation notice stating that your children's enrollment in their Child Health Plus plan was effective March 1, 2017, is correct and must be AFFIRMED.

Decision

The January 25, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your child's eligibility.

The effective date of your child's Child Health Plus plan is March 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
