Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible for the Essential Plan?

Did NY State of Health properly determine that you were ineligible for Medicaid?

Procedural History

On February 18, 2017, you updated your application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective April 1, 2017.

Also on February 18, 2017, you spoke to NY State of Health's (NYSOH) Account Review Unit and appealed insofar as you were not found eligible for Medicaid.

On February 19, 2017, NYSOH issued a notice of eligibility determination, based on the February 18, 2017 application, stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month, effective April 1, 2017. That notice also stated that you were not eligible for Medicaid because your income was over the allowable income limit for that program.

On March 11, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid for a limited time as you had been granted Aid to Continue until a decision was made on your appeal, effective April 1, 2017.

On March 16, 2017, NYSOH issued an enrollment notice confirming your enrollment in a Medicaid Managed Care plan as of April 1, 2017.

On May 23, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are not sure if you will be required to file a tax return for 2017, however, if you do file a tax return for 2017, you will file with a tax filing status of single, and you will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on February 18, 2017 listed annual household income of \$19,080.00, consisting of \$1,590.00 you receive per month in Social Security Disability Benefits. You testified that this amount was correct.
- 4) You testified that you began receiving Social Security Disability Benefits in August 2016, and since that time, this has been your only source of income.
- 5) You testified that if you do file a tax return for 2017, you will not be taking any deductions on that tax return.
- 6) Your application states, and you confirmed, that you live in New York County.
- 7) You testified that you have bills including \$918.06 per month for rent, \$160.00 per month for cable, \$75 to \$100 per month for electric that you would like taken into account when determining your eligibility for financial assistance with health insurance.
- 8) You further testified that you have a number of medical conditions which require frequent doctor's visits and medications and you cannot afford all the associated co-pays.

- 9) You submitted letters from your doctors which document your current medical conditions (Doc. [REDACTED], [REDACTED]).

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, effective April 1, 2017.

The application that was submitted on February 18, 2017 listed an annual household income of \$19,080.00 and the eligibility determination relied upon that information.

During the hearing, you testified that the amount you provided in your application was correct. However, you asked that your current expenses, which include rent, electricity and other living expenses, be considered when calculating your eligibility for financial assistance

Since the Internal Revenue Service rules do not allow living expenses such as rent, utilities, cable and phone to be deducted from the calculation of your adjusted gross income, they cannot be deducted when the NYSOH computes your modified adjusted gross income for APTC purposes. Therefore, NYSOH correctly determined your household income to be \$19,080.00.

You are in a one-person household. If you file a 2017 tax return, you expect to file as single and will claim no dependents on that tax return.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$19,080.00 is 160.61% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$12,060.00 for a one-person household. Since \$19,020.00 is 157.71% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that since August 2016 your monthly income has been \$1,590.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,387. 00 per month. Since the testimony you provided shows that you received \$1,590.00 per

month as of August 2016 you do not qualify for Medicaid on the basis of monthly income as of the date of your application.

Since the February 18, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

Medicaid through NYSOH (called MAGI-based Medicaid) is available to individuals who meet the income requirements and are between the ages of 19 and 64, who are not eligible for Medicare Parts A or B; pregnant women or infants; children between the ages of 1 and 18; and parent or caretaker relatives.

NYSOH does not have the authority to determine whether or not you qualify for non-MAGI-based Medicaid. That authority lies with the New York City Human Resources Administration

During the hearing, you testified that you have not applied for non-MAGI-based Medicaid through New York City Human Resources Administration. Since you may be eligible for Medicaid on a non-MAGI basis, NYSOH will refer your case to the New York City Human Resources Administration for consideration.

Decision

The February 18, 2017 eligibility determination notice is AFFIRMED.

Your case is RETURNED to NYSOH to refer your case to the New York City Human Resources Administration.

How this Decision Affects Your Eligibility

You are eligible for the Essential Plan.

You are ineligible for Medicaid.

Your case is being referred to the New York City Human Resources Administration for consideration of your eligibility for non-MAGI-based Medicaid.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
