## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible to enroll in coverage through NYSOH?

## Procedural History

On February 21, 2017, you submitted an application for health insurance through NYSOH. NYSOH rendered a preliminary eligibility determination that you were not eligible to purchase health insurance through NYSOH.

Also on February 21, 2017, you contacted NYSOH's Account Review Unit and requested an appeal insofar as you were determined not eligible to purchase health insurance through NYSOH.

On February 22, 2017, NYSOH issued an eligibility determination notice, based on your February 21, 2017 application, stating that you were not eligible for Medicaid, Child Health Plus, the Essential Plan, tax credits or cost-sharing reductions, and not eligible to enroll in a qualified health plan at full cost.

On May 30, 2017, you had a telephone hearing, with the assistance of a [REDACTED], with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

## Findings of Fact

A review of the record supports the following findings of fact:

- 1) According to your NYSOH account and testimony, you are applying for health insurance for yourself.
- 2) According to your NYSOH account and testimony, you expect to file a 2017 federal income tax return with the tax status of single and do not expect to claim any dependents on that tax return.
- 3) According to your February 21, 2017 application, your 2017 expected income is \$20,843.00.
- 4) According to your NYSOH account, you do not expect to claim any deductions on your 2017 federal income tax return.
- 5) You testified that your 2017 yearly income is expected to be approximately \$31,000.00.
- 6) According to your February 21, 2017 application, you are an immigrant non-citizen.
- 7) According to your U.S. Employment Authorization card, your current category code is C33 with an expiration date of December 16, 2017 (see Document [REDACTED]; uploaded 08/09/2016).
- 8) You testified that your immigration status has not changed.
- 9) You testified that you want to be determined eligible to enroll in health insurance through NYSOH.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## Applicable Law and Regulations

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the

FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

### Qualified Health Plan

To enroll in a qualified health plan (QHP) through the Marketplace, an applicant must be a citizen or national of the United States or a non-citizen who is lawfully present in the United States and reasonably expects to become a citizen or remain a lawfully present noncitizen for the entire period for which enrollment is being sought (45 CFR § 155.305(a)(1)).

### Lawful Presence

An individual with deferred action under the Department of Homeland Security's deferred action for childhood arrivals process shall not be considered to be lawfully present for the purposes of obtaining coverage through NYSOH (45 CFR § 152.2(8); Center for Medicaid and CHIP Services Memorandum SHO#12-002 "Re: Individuals with Deferred Action for Childhood Arrivals," issued August 28 2012).

### Medicaid – Citizenship/Immigration Status

Generally, no person except a United States citizen, a naturalized citizen, a qualified alien, and persons permanently residing in the United States under color of law (PRUCOL), is eligible for medical assistance from the state (NY Soc. Serv. Law § 122(1); 18 NYCRR § 360-3.2(j)).

A PRUCOL alien is a person who is residing in the United States with the knowledge and permission or acquiescence of the federal immigration agency and whose departure from the United States such agency does not contemplate enforcing (18 NYCRR §360-3.2(j)). The New York Department of Health regards aliens who have been issued an Employment Authorization Document (I-688B or I-766), and have the requisite category code, to be PRUCOL (08 OHIP/INF-4, dated August 4, 2008)).

The guide, "Key to I-766/I-688B, Employment Authorization Documents (EADs)", defines certain codes on the USCIS Employment Authorization Documents" (08 MA/033, dated December 1, 2008, and as amended). It confirms that a person who has category code of "(c)(33)" has PRUCOL status for Medicaid and Child Health Plus only (*id.*).

## Medicaid – Financial Eligibility

A person who meets certain nonfinancial criteria and has a household income that is at or below the applicable Medicaid income standard is eligible for Medicaid benefits (45 CFR § 155.305(c)). One of the non-financial criteria for Medicaid eligibility is the immigration status of the person applying for health insurance. A person is eligible for Medicaid when his or her immigration status is satisfactory and he or she meets all other requirements for Medicaid.

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2017 FPL, which is \$12,060.00 for a one-person household (82 Fed. Reg. 8831).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were not eligible to enroll in health insurance coverage through NYSOH.

On February 22, 2017, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid, Child Health Plus, the Essential Plan, tax credits or cost-sharing reductions, and were not eligible to enroll in a qualified health plan at full cost.

Federal regulations require that a person seeking enrollment in the Essential Plan or a qualified health plan must be a citizen of the United States or have a satisfactory immigration status.

Your employment authorization card states you are an immigrant non-citizen with a C-33 status; that is, Deferred Action for Childhood arrivals status. Individuals who have obtained an Employment Authorization card with the status of C-33 category are persons considered not “lawfully present” for purposes of the federal definition and, therefore, are not recognized as eligible to receive federal funding under those programs.

Since individuals with the Deferred Action for Childhood arrivals status are not considered to be lawfully present for the purposes of obtaining coverage in the Essential Plan or a qualified health plan, NYSOH correctly determined you to be ineligible to enroll in the Essential Plan or a qualified health plan, based on your immigration status.

However, NY State has consistently recognized persons with Deferred Action status within the accepted meaning of “*PRUCOL alien*”; even though the federal government has not. The New York Court of Appeals ruled, in *Aliessa, et al. v. Novello* (96 NY 2d 418 [2001]), that New York must provide state-funded Medicaid to the lawfully residing immigrants who had been excluded from access to the federal Medicaid program.

Since your current Deferred Action status does confer PRUCOL status as an individual seeking Medicaid eligibility, we may review whether you met the financial criteria for Medicaid.

The record reflects that you expected to file your 2017 federal income tax return with the tax status of single and did not expect to claim any dependents on that tax return. Therefore, you are in a one-person household for purposes of this analysis.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size. On the date of your February 21, 2017 application, the relevant FPL was \$12,060.00 for a one-person household.

According to your February 21, 2017 application, you attested to a yearly income of \$20,843.00. Since \$20,843.00 is 175.45% of the 2017 FPL, NYSOH properly found you to be ineligible for Medicaid, based on the fact that your income exceeded the allowable income threshold.

Therefore, the February 22, 2017 eligibility determination notice properly found you to be ineligible for the Essential Plan or QHP based on your immigration status, and ineligible for Medicaid based on your expected annual household income.

## **Decision**

The February 22, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You are not eligible for the Essential Plan or enrollment in a QHP based on your immigration status.

You are not eligible for Medicaid because your household income is over the maximum allowable income limit for a one-person household.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
