#### Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$303.00 per month in advance payments of the premium tax credit (APTC)?

Did NYSOH properly determine that you were eligible for cost-sharing reductions (CSR)?

# **Procedural History**

On February 22, 2017, you submitted an application for financial assistance. That same day, NYSOH rendered a preliminary eligibility determination finding you eligible to receive up to \$303.00 in APTC and CSR.

Also on February 22, 2017, you spoke to NYSOH's Account Review Unit and requested an appeal relative to the amount of financial assistance you were determined eligible to receive.

On February 23, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$303.00 in APTC per month and CSR, effective as of April 1, 2017.

On February 23, 2017, NYSOH issued a plan enrollment notice confirming that as of February 22, 2017, you were enrolled in a qualified health plan with an enrollment start date of April 1, 2017.

On June 5, 2017, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit, in which assisted you. The record was developed during the hearing and closed at the end of the proceeding.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- According to your NYSOH account and testimony, you are seeking insurance for yourself.
- You testified that you expect to file a 2017 federal income tax return with the tax status single and do not expect to claim any dependents on that return.
- 3) According to your February 22, 2017 application, you attested to a 2017 expected income of \$26,000.00.
- 4) According to your NYSOH account and testimony, you do not expect to claim any deductions on your 2017 federal income tax return.
- 5) According to your NYSOH account, you reside in Queens County, New York.
- 6) You testified that you are unable to afford the health insurance premiums even with the subsidies available to you.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

#### Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

 the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution in 2017 is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

#### Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

#### Affordability Exemption

Under some circumstances, a person may receive an exemption from paying a penalty for not purchasing health insurance coverage. Such an exemption may be granted if that person can show that he or she experienced a financial hardship or has domestic circumstances that (1) caused an unexpected increase in essential expenses that prevented that person from obtaining health coverage under a QHP; (2) would have caused the person to experience serious deprivation of food, shelter, clothing, or other necessities, as a result of the expense of purchasing health coverage under a QHP; or (3) prevented that person from obtaining coverage under a QHP (45 CFR § 155.605(a), (g)).

NY State of Health has deferred to the U.S. Department of Health and Human Services (HHS) on the matter of hardship exemptions (see 45 CFR § 155.505(c)).

## Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for APTC of up to \$303.00 per month.

Based on the application that was submitted on February 22, 2017, you attested to an expected annual household income of \$26,000.00 and the eligibility determination relied upon that information.

You testified that you expect to file a 2017 federal income tax return with the tax status of single and do not expect to claim any dependents on that return. Therefore, you are in a one-person household for purposes of this analysis.

You reside in Queens, New York, where the second lowest cost silver plan available for an individual, through NYSOH costs \$456.46 per month.

An annual income of \$26,000.00 is 218.86% of the 2016 FPL for a one-person household. At 218.86% of the FPL, the expected contribution to the cost of the health insurance premium in 2017 is 7.10% of income, or \$153.83 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$456.46 per month) minus your expected contribution (\$153.83 per month), which equals \$302.63 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$303.00 per month in APTC.

The second issue under review is whether NYSOH properly found you eligible for CSR, if you enrolled in a silver-level QHP.

Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$26,000.00 is 218.86%, based on a one-person household and the applicable FPL, NYSOH correctly found you eligible for CSR.

Therefore, the February 23, 2017 eligibility determination notice properly stated that, based on the information you provided, you were eligible for up to \$303.00 per month in APTC and CSR, and is AFFIRMED.

### **Decision**

The February 23, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You remain eligible for up to \$303.00 monthly in APTC.

You remain eligible for CSR.

# If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
