NOTICE OF DISMISSAL – FAILURE TO APPEAR

On February 16, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your parent was eligible to enroll in the Essential Plan with no monthly premiums, effective March 1, 2017. You appealed this determination.

On April 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 31, 2017, at 10:00 a.m.

On May 31, 2017, a Hearing Officer placed two calls to the telephone number that you provided to NYSOH, ([REDACTED]), at 9:00 a.m., and 9:15 a.m., but was unable to reach you after receiving your voicemail. The Hearing Officer then contacted the alternate number in your account ([REDACTED]) at 9:30 a.m. and reached an individual who stated you were at work and to contact you directly.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
