Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your [REDACTED] child's eligibility for financial assistance and enrollment in a qualified health plan ended effective December 31, 2016?

Did NY State of Health properly determine that your [REDACTED] child did not qualify to enroll in a qualified health plan outside of the open enrollment period?

Procedural History

On August 26, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination based on your August 25, 2016 application stating that your [REDACTED] child (child) was conditionally eligible to purchase a qualified health plan at full cost, effective October 1, 2016. The notice further requested that you provide documentation confirming his citizenship status and Social Security number before November 23, 2016.

On August 26, 2016, NYSOH issued a notice confirming your child's enrollment in a qualified health plan.

On November 24, 2016, NYSOH issued a notice of eligibility determination based on your November 23, 2016 application stating your child was conditionally eligible to purchase a qualified health plan at full cost, effective January 1, 2017.

The notice further requested that you provide documentation confirming [REDACTED] citizenship status and Social Security number by November 23, 2016.

On November 24, 2016, NYSOH issued a notice confirming your child's enrollment in qualified health plan starting January 1, 2017.

On November 30, 2016, NYSOH issued an eligibility determination notice stating that your child was not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. [REDACTED] also could not enroll in a qualified health plan at full cost because you had not confirmed [REDACTED] citizenship status and Social Security number within the required timeframe. Your child's eligibility for coverage ended effective December 1, 2016.

On November 30, 2016, NYSOH issued a disenrollment notice terminating your child's enrollment in a qualified health plan starting January 1, 2017. The notice stated this was because [REDACTED] was no longer eligible to enroll in health insurance through NYSOH.

On December 6, 2016, NYSOH issued an eligibility determination notice stating your child was eligible to purchase a qualified health plan at full cost effective January 1, 2017. The notice stated that you needed to pick a plan for your child.

On February 17, 2017, NYSOH issued an eligibility determination notice stating your child may be eligible to enroll in coverage if [REDACTED] qualified for a special enrollment period effective April 1, 2017.

On February 22, 2017, NYSOH received your child's updated application for health insurance. That day, a preliminary determination was made stating [REDACTED] was eligible to purchase a qualified health plan at full cost effective April 1, 2017. That day, you attempted to reenroll your child into coverage but were unable to.

On February 22, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination insofar as it ended your child's financial assistance eligibility and enrollment in a qualified health plan on December 31, 2017, and that you were unable to reenroll him in a health plan.

On May 31, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you receive all of your notices from NYSOH via regular mail.
- 2) You testified that you did not receive any notices stating that your child's eligibility was only conditional and that you needed to provide documentation of his citizenship status.
- 3) No notices that were sent to the address listed on your NYSOH account have been returned as undeliverable.
- 4) You testified that you did not know that you knew you needed to provide your child's Social Security number.
- 5) You testified you may have mailed your child's Social Security card in October or November, 2016.
- 6) The record reflects that on December 1, 2016 NYSOH received documentation of your child's Social Security card and birth certificate.
- 7) Your child was disenrolled from this qualified health plan December 31, 2016.
- 8) You testified that you are seeking reinstatement of your child's qualified health plan.
- 9) Your child was born on [REDACTED].
- 10) Your application that was submitted August 25, 2016 stated you were in the process of applying for a Social Security number for your child.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Citizenship and Immigration Status

To enroll in a qualified health plan through NYSOH, an applicant must be a citizen or national of the United States, or a non-citizen who is lawfully present in the United States and reasonably expects to become a citizen or remain a lawfully present noncitizen for the entire period for which enrollment is being sought (45 CFR § 155.305(a)(1)).

NYSOH must verify or obtain information in order to determine that an applicant is eligible for enrollment in a qualified health plan, including the certification of citizenship, status as a national, or lawful presence (45 CFR § 155.315(a), (c)).

If an applicant attests to citizenship, status as a national, or lawful presence, and NYSOH is unable to verify such attestation, NYSOH must provide the applicant with notice of the inconsistency. NYSOH must then provide the applicant with 90 days to provide satisfactory documentary evidence, from the date the notice of inconsistency is received by the applicant. Notice is considered received 5 days after the date on the notice, unless the applicant demonstrates that he or she did not receive the notice within the 5-day period. (45 CFR § 155.315(c)(3), (f)(2)(i)).

If NYSOH remains unable to verify the citizenship attestation after the 90-day period ends, it must determine the applicant's eligibility based on the information available (45 CFR § 155.315(f)(5)).

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.

(iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.

(2)(i) The qualified individual gains a dependent or becomes a dependent through marriage, birth, adoption, placement for adoption, or placement in foster care, or through a child support order or other court order.

(ii) the enrollee loses a dependent or is no longer considered a dependent through divorce or legal separation as defined by State law in the State in which the divorce or legal separation occurs, or if the enrollee, or his or her dependent, dies.

(3) The qualified individual, or his or her dependent, becomes newly eligible for enrollment in a qualified health plan because he or she gains citizenship, status as a national, or lawful present or is no longer incarcerated.

(4) The qualified individual's or his or her dependent's, enrollment or non-enrollment in a qualified health plan is unintentional, inadvertent, or erroneous and is the result of the error, misrepresentation, misconduct, or inaction of an officer, employee, or agent of NYSOH, its instrumentalities, or a non-NYSOH entity providing enrollment assistance or conducting enrollment activities.

(5) The enrollee or, his or her dependent adequately demonstrates to NYSOH that the qualified health plan in which he or she is enrolled substantially violated a material provision of its contract in relation to the enrollee;

(6) The enrollee or enrollee's dependent is newly eligible or ineligible for advance payments of the premium tax credit, or change in eligibility for cost-sharing reductions.

(7) The qualified individual or enrollee, or his or her dependent, gains access to new qualified health plan as a result of a permanent move and either—

(i) Had minimum essential coverage for one or more days during the 60 days preceding the date of the permanent move, or

(ii) Was living outside of the United States or in a United States territory at the time of the permanent move;

(8) The qualified individual or dependent who gains or maintains status as an Indian may enroll in a qualified health plan or change from one plan to another, once per month.

(9) The qualified individual or enrollee, or his or her dependent, demonstrates to the Exchange, in accordance with guidelines issued by HHS, that the individual meets other exceptional circumstances as the Exchange may provide;

(10) A qualified individual or enrollee—

(i) Is a victim of domestic abuse or spousal abandonment, including a dependent or unmarried victim within a household, is enrolled in minimum essential coverage and seeks to enroll in coverage separate from the perpetrator of the abuse or abandonment; or

(ii) Is a dependent of a victim of domestic abuse or spousal abandonment, on the same application as the victim, may enroll in coverage at the same time as the victim;

(11) A qualified individual or dependent—

(i) Applies for coverage through NYSOH during the annual open enrollment period or due to a qualifying event, is assessed as potentially eligible for Medicaid or Child Health Plus and is determined ineligible for Medicaid or Child Health Plus either after open enrollment has ended or more than 60 days after the qualifying event; or

(ii) Applies for coverage at their Local Department of Social Services or Human Resources Administration during the annual open enrollment period, and is determined ineligible for Medicaid or Child Health Plus after open enrollment has ended;

(12) The qualified individual or enrollee, or his or her dependent, adequately demonstrates to NYSOH that a material error related to plan benefits, service area, or premium influenced the qualified individual's or enrollee's decision to purchase a qualified health plan; or

(13) At the option of NYSOH, the qualified individual provides satisfactory documentary evidence to verify his or her eligibility for an insurance affordability program or enrollment following termination of enrollment due to a failure to verify such status within 90 days. NYSOH has elected against this option.

(45 CFR § 155.420(d)).

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that your child was no longer eligible to enroll in a qualified health plan through NYSOH, effective December 31, 2016.

NYSOH is required to determine whether individuals are eligible to enroll in coverage through NYSOH, and must confirm, among other things, that their citizenship status is satisfactory.

If NYSOH cannot verify an individual's citizenship status, it must provide the individual with notice of the inconsistency. NYSOH must then provide the individual with a period of 90 days from the date notice is received to resolve the inconsistency. For purposes of verifying citizenship, notice is considered received 5 days after the date on the notice.

In the eligibility determination issued on August 26, 2016, you were advised that your child's eligibility was only conditional, and that you needed to confirm his Social Security number and citizenship status before November 23, 2016.

The record reflects that NYSOH did not receive the requested citizenship documentation before the deadline. It was not until December 1, 2016 that your child's Social Security card and Certificate of Birth were received by NYSOH.

You testified that you did not receive any notice from NYSOH telling you that you needed to update the information in your NYSOH account. You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, the record reflects that NYSOH properly notified you of your annual renewal and that information in your NYSOH account needed to be updated in order to ensure your enrollment in your health plan and eligibility for financial assistance would continue, and you did not submit the requested citizenship documentation before the stated deadline.

If NYSOH remains unable to verify the inconsistency after the 90-day period ends, then it must determine the applicant's eligibility based on the information available in the data sources.

Since the requested citizenship documentation was not received within the 90-day period, NYSOH was required to redetermine your child's eligibility without verification of his citizenship status. Because the information was still unavailable in his account, NYSOH properly determined that he could not enroll in a qualified health plan through NY State of Health effective December 1, 2016 because you did not provide the information requested by NYSOH.

Therefore, NYSOH's November 30, 2016 eligibility determination is correct and is AFFIRMED.

The second issue under review is whether NYSOH properly determined that your child did not qualify to enroll in a qualified health plan outside of the open enrollment period.

You testified that you are appealing the denial of a special enrollment period to enroll your child into a health plan through NYSOH. However, the record does not contain a notice of eligibility determination or redetermination on the issue of special enrollment period denial.

Here, the lack of a notice of eligibility determination on the issue of special enrollment periods does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue a notice of eligibility determination as you are to appeal an adverse notice of eligibility determination. Your credible testimony permits an inference that NYSOH did deny your special enrollment request.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the eligibility determination notice had it been issued.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On February 22, 2017, you submitted an application for health insurance and requested to reenroll in your child in a qualified health plan. That same day an incident was filed and an appeal filed for the issue of denial of a special enrollment period.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period in order to enroll in, or change to another health plan offered in NYSOH. In order to qualify for a special enrollment period, a person must experience a triggering event.

Loss of insurance coverage is considered a triggering life event. However, your child's loss of coverage was a result of you not submitting the requested documentation of [REDACTED] citizenship status and Social Security number within the requested time frame. As such, it is considered a voluntary loss of coverage and

is not considered a triggering event for the purposes of granting a special enrollment period.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you for a special enrollment period.

Therefore, NYSOH's February 22, 2017 verbal denial that your child did not qualify to select a health plan outside of the open enrollment period for 2017 is **AFFIRMED**.

Decision

The November 30, 2016, notice of eligibility determination is **AFFIRMED**.

NYSOH's February 22, 2017 verbal denial of a special enrollment period is **AFFIRMED**.

How this Decision Affects Your Eligibility

NYSOH properly found your child not eligible to enroll in a qualified health plan December 1, 2016, because you did not submit proof of [REDACTED] Social Security number and citizenship status.

Your child does not qualify for a special enrollment period at this time.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the
