Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid from November 1, 2016 through November 30, 2016?

Procedural History

On January 19, 2017, you submitted an updated application for financial assistance with health insurance and indicated that you were seeking help with paying for medical bills from the last three months.

On January 21, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 premium per month for a limited time, effective March 1, 2017.

Also on January 21, 2017, NYSOH issued a plan enrollment notice confirming that you were enrolled in an Essential Plan with a March 1, 2017 start date.

On February 22, 2017, you spoke with NYSOH's Account Review Unit and appealed not being determined eligible for Medicaid during the month of November 2016.

On April 11, 2017, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid from November 1, 2016 through November 30, 2016. The reason stated was because the monthly household income you provided of \$2,633.33 was over the allowable monthly income limit of \$2,319.00.

On May 25, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open to June 9, 2016, to allow you to submit supporting documents.

On June 7, 2017, NYSOH received the requested documentation and it was made part of the record as "Appellant's Exhibit #1." The record was closed that day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid from November 1, 2016 through November 30, 2016 because you [REDACTED] that month and were without insurance.
- 2) You testified that you expect to file your 2017 federal income tax return as head of household with qualifying individuals and will claim two dependents on your tax return.
- 3) You submitted an application for financial assistance on January 19, 2017, and indicated on that application that you needed help paying for medical bills from the past three months.
- 4) You were determined eligible for the Essential Plan on January 20, 2017, as stated in the January 21, 2017 eligibility determination notice
- 5) You uploaded to your NYSOH account and faxed to NYSOH's Appeals Unit paystubs from your two places of employment for the month of November 2016, which showed gross earnings received that month of \$2,858.87 as follows:

- 6) According to your NYSOH account, you do not plan on taking any deductions on your tax return

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$20,160.00 for a three-person household (81 Fed. Reg. 4036).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid from November 1, 2016 through November 30, 2016.

You file your taxes with a tax filing status of head of household with qualifying individuals and will claim two dependents on your tax return. Therefore, you are in a three-person household for purposes of this analysis.

You submitted an application for financial assistance on January 19, 2017, in which you requested help in paying for medical bills for the three previous months. You testified that you are seeking Medicaid for the month of November 2016.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in November 2016, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the applicable FPL, which is \$2,319.00 per month for a three-person household. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria that month.

You testified that you received earnings from two employers in November 2016. According to the paystubs you submitted, your gross earnings from your one employment were \$227.07; and from the other employment were \$2,641.80. Therefore, the record indicates that in the month of November 2016, you had a monthly household income of \$2,868.87.

Since your income of \$2,868.87 was more than the \$2,319.00 maximum allowable monthly income limit to be eligible for Medicaid in the month of November 2016, NYSOH properly determined that you were not eligible for Medicaid coverage during that month. Therefore, the April 11, 2017 eligibility determination notice stating that you were not eligible for Medicaid in the month of November 2016, is correct and is AFFIRMED.

Decision

The April 11, 2017 eligibility determination notice is AFFIRMED.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
