Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for November 2016?

Procedural History

On December 7, 2016, you submitted two applications for financial assistance with health insurance. One of the applications indicated that you were seeking help for paying for medical bills for the previous three months.

On December 8, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid. This eligibility was effective as of December 1, 2016.

Also on December 8, 2016, NYSOH issued an enrollment confirmation notice, stating that your enrollment in a Medicaid Managed Care (MMC) plan would begin January 1, 2017.

On December 30, 2016, NYSOH received your updated application for financial assistance. That application indicated that you were seeking help paying for medical bills from October 2016.

On December 31, 2016, NYSOH issued an eligibility determination notice stating that you remained eligible for Medicaid effective December 1, 2016.

Also on December 31, 2016, NYSOH issued an eligibility determination notice stating that your request for retroactive Medicaid coverage for October 2016 was granted.

On February 7, 2017, NYSOH received your updated application for financial assistance.

Also on February 7, 2017, you uploaded a paystub dated November 17, 2016 for a gross pay of \$396.00.

On February 8, 2017, NYSOH issued an eligibility determination notice stating that you remained eligible for Medicaid, effective February 1, 2017.

On February 23, 2017, you spoke to NYSOH's Account Review Unit and filed an appeal, insofar as you had not been granted retroactive Medicaid coverage for November 2016.

On April 7, 2017, you uploaded a paystub dated November 3, 2016 for a gross pay of \$408.00.

On June 5, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for November 2016.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You submitted an application for financial assistance on December 7, 2016.
- 4) You testified that you are paid bi-weekly and have one employer.
- 5) You testified that you do not have any other sources of income.
- 6) You uploaded a paystub dated November 3, 2016 for a gross pay amount of \$408.00 and a paystub dated November 17, 2016 for a gross pay amount of \$396.00, which yields a monthly gross income for November 2016 of \$804.00.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

De Novo Review

NYSOH Appeals Unit must review each appeal de novo and “consider all relevant facts and evidence adduced during the appeals process” (45 CFR § 155.535(f)). “De novo review means a review of an appeal without deference to prior decisions in the case” (45 CFR § 155.500).

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid for November 2016.

You testified that you are appealing the denial of a retroactive Medicaid for November 2016. However, the record does not contain a notice of eligibility determination or redetermination on the issue of retroactive coverage for November 2016.

Here, the lack of a notice of eligibility determination on the issue of retroactive Medicaid coverage for November 2016 does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue a notice of eligibility determination as you are to appeal an adverse notice of eligibility determination.

Your credible testimony along with the February 24, 2017 appeal confirmation notice stating that the reason for your appeal was “eligibility determination”, permits an inference that NYSOH did deny your request for retroactive Medicaid coverage in November 2016.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the eligibility determination notice had it been issued.

You are in a one-person household; you file your taxes with a tax filing status of single and claim no dependent on your tax return.

You submitted an application for financial assistance on December 7, 2016 and requested help in paying for medical bills for the previous three months.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual’s initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

You testified that you are seeking Medicaid for November 2016.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

To be eligible for Medicaid in November 2016, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,367.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during November 2016.

You testified that you are paid bi-weekly. You uploaded a paystub dated November 3, 2016 for a gross pay amount of \$408.00 and a paystub dated November 17, 2016 for a gross pay amount of \$396.00. Therefore, the record indicates that in the month of November 2016, you had a monthly household income of \$804.00.

Since the record now contains a more accurate representation of what your income was for the month of November 2016, your case is RETURNED to NYSOH to consider your request for retroactive Medicaid coverage based on a household size of one and household income of \$804.00 for the month of November 2016.

Decision

Your case is RETURNED to NYSOH to consider your request for retroactive Medicaid coverage based on a household size of one and household income of \$804.00 for the month of November 2016.

How this Decision Affects Your Eligibility

This is not a final determination of your eligibility. Your case is sent back to NYSOH to redetermine your eligibility.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.
