NOTICE OF DISMISSAL – INVALID APPEAL REQUEST

On January 11, 2017, NY State of Health (NYSOH) prepared an eligibility determination and found your children eligible to enroll in a full price Child Health Plus plan, effective February 1, 2017.

Also on January 11, 2017, a plan enrollment notice was issued confirming your children's enrollment in a Child Health Plus plan for a cost of \$384.52 per month, effective February 1, 2017.

On February 27, 2017, you filed an appeal insofar as your children's Child Health Plus monthly premiums were at full cost. On May 16, 2017, you renewed your appeal request.

You testified at your Hearing on July 17, 2017, which was based on your February 27, 2017 appeal request, that instead of being charged \$384.52 per month for your children's Child Health Plus plan, you are now being charged \$460.00 per month.

An incident filed on February 27, 2017 states a NYSOH representative reviewed with you your CHP invoices for March 2017 and April 2017. Your new full pay Child Health Plus rate had increased from \$192.96 per child per month to \$228.72 per child per month, effective March 1, 2017. Your children's Child Health Plus premiums further increased to \$235.21 per child per month, effective April 1, 2017.

You testified that you filed an appeal because you believe the premium responsibility stated in the January 11, 2017 enrollment confirmation notice should be honored and not the increased premium cost requested by your health plan, because your children's CHP premium is supposed to be "locked in" for twelve months.

Why Your Appeal Request Is Not Valid

An applicant has the right to appeal to NYSOH's Appeals Unit: (1) an eligibility determination, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (2) a redetermination of eligibility, including the amount of advance payments of the premium tax credit and level of cost-sharing reductions; (3) an eligibility determination for an exemption; (4) a failure by the Exchange to provide timely notice of an eligibility determination 45 CFR § 155.505; and (5) a denial of a request for a special enrollment period (45 CFR § 155.505(b)(1)(iii), 45 CFR § 155.305(b), and 45 CFR § 155.420(d)).

Your appeal was requested to dispute the Child Health Plus premium amount charged by your health plan, and not your children's eligibility for Child Health Plus, or the start date of their Child Health Plus plan. This issue relates to the cost of premiums/full rate premiums decided upon by your health plan, which is not an issue that the NY State of Health Appeals Unit is authorized to address. Therefore, we must dismiss your appeal.

How does this Dismissal Affect Your Eligibility?

This decision does not change your children's current eligibility for or enrollment in a Child Health Plus plan, or the monthly premium amount that you pay for their health plan.

You may have additional options outside of NYSOH's Appeals Unit, such as through your plan or through NYS Department of Financial Services.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. In that writing, you must explain why you think this dismissal should be vacated and if your issue differs from the one discussed above.
