NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On February 17, 2017, NY State of Health (NYSOH) issued a disenrollment notice stating that your children's Child Health Plus coverage would end on February 28, 2017.

On February 28, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal because your children's health plan was terminated effective February 28, 2017, and were not enrolled in health insurance coverage for the month of March 2017.

On March 1, 2017, NYSOH issued an enrollment notice confirming that as of February 24, 2017, your children were enrolled in a Child Health Plus plan with an enrollment start date of April 1, 2017.

On May 14, 2017, NYSOH issued an enrollment notice confirming that your children were enrolled in a Child Health Plus plan with an enrollment start date of March 1, 2017.

On June 14, 2017, you had a scheduled telephone hearing with a Hearing Officer from the NYSOH's Appeals Unit. You requested that the hearing be adjourned and waived formal notice of telephone hearing. The adjournment was granted and rescheduled for June 15, 2017 at 1:00 pm.

On June 15, 2017, you were contacted by a Hearing Officer from the NYSOH's Appeals Unit. At the rescheduled hearing, you confirmed that you no longer wanted to pursue your appeal based on the fact that your children were enrolled in a Child Health Plus plan in the month of March 2017. You withdrew your appeal on the record through sworn testimony.

Accordingly, we are dismissing your appeal.

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

This dismissal will not affect any determinations made after the appeal request.

If You Think Your Appeal Should Not Be Dismissed

Under some circumstances, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing you also must state a good reason for us to do this.

If you ask us in writing to vacate this dismissal, NYSOH's Appeals Unit will review your request and send you a decision on that request.

If we deny your request to vacate this dismissal, we will tell you that in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed. No further action will be taken on it by NYSOH.
