## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that properly determine that you were not eligible for Medicaid, effective February 1, 2017?

## Procedural History

On December 27, 2016, you updated your NYSOH application.

On December 28, 2016, NYSOH issued an eligibility redetermination notice stating that you were conditionally eligible to purchase a qualified health plan at full cost, effective February 1, 2017. The notice requested that you provide proof of termination of Medicare Part A and Part B coverage by February 10, 2017.

On January 3, 2017, you updated your NYSOH application to reflect that you have coverage under Medicare.

On January 4, 2017, NYSOH issued an eligibility redetermination notice stating that you were not eligible for Medicaid, Child Health Plus, the Essential Plan, to receive an advance premium tax credit, cost sharing reductions or to purchase a qualified health plan from NYSOH at full cost because state and federal sources show that you are receiving Medicare. The notice stated that individuals enrolled in Medicare cannot receive health coverage through NYSOH. The eligibility was effective February 1, 2017.

On February 14, 2017, you updated your NYSOH application.

On February 15, 2017, NYSOH issued an eligibility determination stating that you were not eligible for Medicaid, Child Health Plus, the Essential Plan, to receive an advance premium tax credit, cost sharing reductions or to purchase a qualified health plan from NYSOH at full cost because state and federal sources show that you are receiving Medicare. The notice stated that individuals enrolled in Medicare cannot receive health coverage through NYSOH.

On February 28, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of the February 15, 2017 eligibility determination notice insofar as you were not found eligible for Medicaid.

On June 7, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are [REDACTED].
- 2) You testified that you are married and have one dependent.
- 3) You testified that you are [REDACTED].
- 4) You testified that you receive \$1,169.00 per month in SSA benefits.
- 5) You testified that you are currently enrolled in Medicare Part A, but not Part B.
- 6) You testified and NYSOH records reflect that you have been enrolled in Medicare Part A since December 1, 2014.
- 7) You live in [REDACTED], New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid Eligibility

An individual is eligible for enrollment in Medicaid through NYSOH (called MAGI-based Medicaid) when he or she meets certain nonfinancial criteria and has a household income that is at or below the applicable Medicaid income standard (45 CFR § 155.305(c); NY Social Services Law § 366(1)(b)).

Medicaid can be provided through NYSOH to adults who meet the following non-financial criteria: (1) Are age 19 or older and under age 65; (2) Are not pregnant; (3) Are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act; (4) Are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part; and (5) Have a household modified adjusted gross income that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

If an individual does not fall into one of these categories, he or she may still be eligible for non-MAGI-based Medicaid coverage through their Local Department of Social Services or the New York City Human Resources Administration (see NY Social Services Law § 366(1)(c)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that you are not eligible for Medicaid effective February 1, 2017.

To be eligible for MAGI-based Medicaid through NYSOH, a person cannot be entitled to or enrolled in Medicare Part A or B. You testified that you are currently enrolled in Medicare Part A. NYSOH records reflect that you were enrolled in Medicare Part A since December 1, 2014. Therefore, you are not eligible for Medicaid through NYSOH and the January 4, 2017 and February 15, 2017 eligibility determination notices are AFFIRMED.

NYSOH does not have the authority to decide if you qualify for non-MAGI-based Medicaid. Since you may be eligible for Medicaid on a non-MAGI basis, NYSOH will refer your case to your local Department of Social Services to determine your eligibility for Medicaid or other Medicare programs.

## **Decision**

The January 4, 2017 and February 15, 2017 eligibility determination notices are AFFIRMED.

## **How this Decision Affects Your Eligibility**

You do not qualify for Medicaid through NYSOH.

NYSOH does not have the authority to decide if you qualify for non-MAGI based Medicaid. Since you may be eligible for Medicaid on a non-MAGI basis, NYSOH will refer your case to your local Department of Social Services office for consideration, if it has not already done so.

The local Department of Social Services in your county will determine your eligibility for Medicaid or other Medicare programs.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
