## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective March 1, 2017?

## Procedural History

On September 18, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan, effective November 1, 2016.

Also on September 18, 2016, NYSOH issued a notice of enrollment confirmation stating that you remained enrolled in an Essential Plan, effective May 1, 2016.

On January 30, 2017, you updated your NYSOH account to reflect that you were pregnant with one child, with an expected due date of [REDACTED].

On January 31, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid, effective January 1, 2017.

Also on January 31, 2017, NYSOH issued a notice of enrollment in the plan you selected on January 30, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage in that plan would start on March 1, 2017.

Also on January 31, 2017, NYSOH issued a disenrollment notice stating that your coverage in an Essential Plan ended effective February 28, 2017.

On March 1, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin February 1, 2017.

On June 9, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You were eligible for and enrolled in an Essential Plan, effective May 1, 2016.
- 2) On January 30, 2017, you updated your NYSOH account to reflect that you were pregnant with one child, with an expected due date of [REDACTED].
- 3) On January 30, 2017, you were determined eligible for Medicaid, effective January 1, 2017.
- 4) You testified, and the record reflects, that you selected your Medicaid Managed Care Plan on January 30, 2017, and that your enrollment was effective on March 1, 2017.
- 5) Your child was born on [REDACTED].
- 6) You testified that you want your Medicaid Managed Care plan to begin on February 1, 2017 because you incurred medical costs in February 2017 related to labor and delivery and your provider does not accept Medicaid Fee-for-Service coverage.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for Medicaid Fee-for-Service effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in a Medicaid Managed Care plan was effective March 1, 2017.

NYSOH records reflect that you were eligible for and enrolled in an Essential Plan, effective May 1, 2016.

You testified that on January 30, 2017, you updated your NYSOH account to reflect that you were pregnant with one child, with an expected due date of [REDACTED]. Also on that date, you testified that you were determined eligible for Medicaid, effective January 1, 2017.

You testified that also on January 30, 2017, you enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On January 30, 2017, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the following month after February; that is, on March 1, 2017.

Therefore, the January 31, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective March 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The January 31, 2017 enrollment confirmation notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is March 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
