NOTICE OF DISMISSAL – FAILURE TO APPEAR

On February 19, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your family was enrolled in a Medicaid Managed Care plan, effective April 1, 2017. You appealed this determination.

On May 5, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for May 30, 2017, at 3:00 p.m.

On May 30, 2017, a Hearing Officer attempted to call you at the telephone number that you provided to NYSOH at 3:03 p.m., 3:11 p.m., and 3:20 p.m., but on the third attempt to reach you, a female answered the phone number you provided, [REDACTED] and stated to the Hearing Officer that she had an incorrect telephone number. The Hearing Officer repeated the number listed above to the female who answered the telephone and she stated that the Hearing Officer had dialed correctly but that she did not know who you are. Please contact NYSOH immediately and update your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
