NOTICE OF DISMISSAL – FAILURE TO APPEAR

On March 3, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating you were enrolled in a Medicaid Managed Care plan and your child was enrolled in a Child Health Plus plan, effective April 1, 2017. You appealed the effective coverage date of these health plans.

On May 16, 2017, NYSOH issued a Notice of Hearing to advise you the hearing you requested was scheduled for June 26, 2017, at 1:00 p.m.

On June 26, 2017, a Hearing Officer attempted to call you at the telephone number you provided to NYSOH at 1:00 p.m., but the call was disconnected after the Hearing Officer asked to speak with you, and at 1:02 p.m., but an individual answered and indicated he did not know who you were and that the telephone number listed on your account was not the correct telephone number for you. Please contact NYSOH immediately and update your account with accurate contact information.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled regarding this appeal.
