Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan with dental and vision coverage was effective April 1, 2017?

Procedural History

On February 15, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your February 14, 2017 application, stating that you were eligible to enroll in the Essential Plan with a \$20.00 monthly premium, for a limited time, effective March 1, 2017. This notice further stated that you may choose to also enroll into dental and vision benefits for an additional premium.

Also on February 15, 2017, NYSOH issued a notice of enrollment, based on your plan selection on February 14, 2017, stating that you were enrolled in an Essential Plan with a \$20.00 monthly premium, and that your plan would start January 1, 2017.

On March 6, 2017, you selected an Essential Plan with dental and vision coverage for an enrollment, effective April 1, 2017.

Also on March 6, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan with dental and vision coverage insofar as it did not begin March 1, 2017.

On March 7, 2017, NYSOH issued a notice of enrollment, based on your plan selection on March 6, 2017, stating that you were enrolled in an Essential Plan with dental and vision coverage, effective April 1, 2017.

Also on March 7, 2017, NYSOH issued a disenrollment notice confirming your disenrollment from your Essential Plan without dental and vision, effective March 31, 2017.

On June 16, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on February 14, 2017.
- 2) You testified that you enrolled into an Essential Plan on February 14, 2017 thinking that you would have full coverage; including dental and vision coverage.
- 3) You further testified that you did not become aware that you did not have dental and vision coverage until your dentist informed you that your Essential Plan did not cover your dental procedure.
- 4) You testified, and the record reflects, that you enrolled in an Essential Plan with dental and vision coverage on March 6, 2017.
- 5) You testified that you wanted your enrollment in an Essential Plan with dental and vision coverage to begin on March 1, 2017 because you have unpaid dental bills from that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan with dental and vision coverage was effective April 1, 2017.

You testified, and the record indicates, that you updated your NYSOH application on February 14, 2017. As a result, you were found eligible for the Essential Plan as of March 1, 2017, and enrolled into a plan that day. You testified that you were not aware that you needed to select a plan that included dental and vision coverage, but that you thought any Essential Plan meant that you had full coverage.

However, NYSOH issued an eligibility determination on February 15, 2017 which indicated that you may choose to also enroll in dental and vision benefits for an additional monthly premium. As a result, NYSOH informed you that in order to ensure coverage for dental and vision that you would have to enroll into an Essential Plan with dental and vision coverage and pay a higher premium amount. You did not attempt to enroll into an Essential Plan with dental and vision coverage until March 6, 2017

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On March 6, 2017, you selected an Essential Plan with dental and vision coverage, so your enrollment properly took effect on the first day of the first month following March 2017; that is, on April 1, 2017.

Therefore, the March 7, 2017 enrollment confirmation notice stating that your enrollment in the Essential Plan with dental and vision coverage was effective April 1, 2017, is correct and must be AFFIRMED.

Decision

The March 7, 2017 enrollment confirmation is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Health Plan with dental and vision coverage is April 1, 2017.

This Decision has no effect on any subsequent eligibility determination notices issued by NYSOH.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
