## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$196.00 per month in advance payments of the premium tax credit, effective April 1, 2017?

Did NYSOH properly determine that you were not eligible for cost-sharing reductions?

Did NYSOH properly determine that you were not eligible for the Essential Plan?

## Procedural History

On March 6, 2017, you provided several updates to your application for financial assistance. That day, a preliminary eligibility determination was prepared resulting from the last application update you provided on March 6, 2017, stating that you were eligible to receive up to \$196.00 in APTC and, if you enrolled in a silver-level qualified health plan (QHP), eligible to receive cost-sharing reductions (CSR), effective April 1, 2017.

Also on March 6, 2017, you spoke to NYSOH's Account Review Unit and appealed that you were found eligible to enroll in a QHP and receive up to \$196.00 in APTC, rather than being found eligible to enroll in the Essential Plan.

On March 7, 2017, NYSOH issued a notice of eligibility determination, based on the March 6, 2017 application, stating that you were eligible to receive up to \$196.00 in APTC and, if you enrolled in a silver level qualified health plan, eligible to receive CSR, effective April 1, 2017. That notice also stated that you were not eligible for the Essential Plan because your income was over the allowable income limits for that program.

On June 13, 2017, NYSOH received a record of medications you have been prescribed.

On June 14, 2017, NYSOH received (1) two earnings statements issued to you by your employer, [REDACTED], on September 9, 2016 and May 15, 2017, (2) a summary of your New York Income tax return for 2015 and a list of itemized deductions (Schedule A) for your federal tax return submitted for 2015, (3) a rental agreement between you and your landlord, [REDACTED], (4) an invoice issued to you by Empire BlueCross BlueShield for coverage for your child during June 2017, (5) a credit card statement issued to you by [REDACTED] (6) a letters issued by your physicians, dated May 25, 2017 and June 6, 2017, (7) a schedule of appointments and payment remitted for January 2016, (8) various prescriptions and invoices issued to you by your physicians, and (9) W-2 Forms issued to you by your employer for 2015 and 2016.

On June 15, 2017, NYSOH received (1) a letter issued to you by your employer, dated June 14, 2017, reflects that your annual gross salary for 2015 and 2016, as well as you projected annual salary for 2017, (2) a schedule of tuition and fees and the accompanying contract for [REDACTED] during 2015-2016 school year, (3) account information for your [REDACTED], and (4) multiple receipts from [REDACTED].

Also on June 15, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim your child as your sole dependent on that tax return.
- 2) You are seeking insurance for yourself, since you child was already separately enrolled in a Child Health Plus plan through the NYC Human Resources Administration.

- 3) The application that was submitted on March 6, 2017 listed annual household income of \$39,120.00, consisting solely of income you anticipate receiving from your employment with [REDACTED]. You testified that this amount was correct.
- 4) Your application states that you do not anticipate taking any deductions on your 2017 tax return.
- 5) You live in Queens County, New York.
- 6) You testified that you have bills including rent, cable, and car payment that you think should be deducted from your household income.
- 7) You further testified that the medical expenses that you currently incur make having a health plan through NYSOH, even after applying the \$196.00 in tax credits, unaffordable. You were seeking to be found eligible for the Essential Plan going forward.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

*minus*

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

### Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Fed. Reg. 4036).



A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

### Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term "modified adjusted gross income" means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

"Adjusted gross income" means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income. Furthermore, medical expenses incurred are not an allowable deduction to reduce your adjusted gross income.

## **Legal Analysis**

The first issue is whether NYSOH properly determined that you were eligible for an APTC of up to \$196.00 per month.

The application that was submitted on March 6, 2017 listed an annual household income of \$39,120.00. During the hearing, you testified that the amount you provided in your application was correct. However, you asked that your current expenses, which include rent, electricity and other living expenses, be considered when calculating your annual household income.

Since the Internal Revenue Service rules do not allow living expenses such as rent, utilities, cable and phone to be deducted from the calculation of your adjusted gross income, they cannot be deducted when the NYSOH computes your modified adjusted gross income for APTC purposes. Therefore, NYSOH correctly determined your household income to be \$39,120.00.

The eligibility determination relied upon that information.

You are in a two-person household. You expect to file your 2017 income taxes as single and will claim your child as a dependent on that tax return.

You reside in Queens County, where the second lowest cost silver plan available for an individual through NYSOH costs \$456.46 per month.

An annual income of \$39,120.00 is 244.19% of the 2016 FPL for a two-person household. At 244.19% of the FPL, the expected contribution to the cost of the health insurance premium is 8.00% of income, or \$260.91 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$456.46 per month) minus your expected contribution (\$260.91 per month), which equals \$195.55 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$196.00 per month in APTC.

The second issue is whether you were properly found eligible for CSR.

CSR is available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$39,120.00 is 244.19% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,020.00 for a two-person household. Since an annual household income of \$39,120.00 is 244.19% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

Since the March 7, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for up to \$196.00 per month in APTC, eligible for CSR, and ineligible for the Essential Plan, it is correct and is **AFFIRMED**.

At the sole authority of the NYSOH Appeals Unit, you are awarded a special enrollment period in which to select a QHP within 60 day of the date of this Decision.

## **Decision**

The March 7, 2017 eligibility determination notice is **AFFIRMED**.

Your case is **RETURNED** to NYSOH. At the sole authority of the NYSOH Appeals Unit, you are awarded a special enrollment period in which to select a QHP within 60 days of the date of this Decision.

## **How this Decision Affects Your Eligibility**

You remain eligible for and APTC of up to \$196.00 per month, and if you select a silver-level plan, eligible for CSR.

You are ineligible for the Essential Plan.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
