NOTICE OF DISMISSAL

On March 7, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your daughter was eligible for the Essential Plan for a limited time for \$0.00 per month effective April 1, 2017. The notice stated her eligibility was based on the condition that she provide additional information in the form of her Social Security Number by June 4, 2017. You appealed this determination.

On May 12, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for June 15, 2017, at 10:00 a.m.

A Hearing Officer called you on June 15, 2017 at 10:00 a.m. Although you answered the phone, identified yourself and were sworn in, you testified you were not aware of a phone hearing for that day. During the call, you requested that you have your [REDACTED] be available for the hearing as a representative on your behalf. The Hearing Officer adjourned the hearing to a later date and time for you to speak to your Broker about the issue you had appealed.

On June 27, 2017, NYSOH issued a Notice of Hearing to you and your Broker to advise you that the hearing you requested was scheduled for August 8, 2017, at 9:00 a.m.

A Hearing Officer called you on August 8, 2017, at 9:00 a.m. Although you answered the call, you refused to proceed with the hearing and stated you needed to call your son, and you would call back. The Hearing Officer explained to you that you would not be able to call back in to the Appeals Unit. You then stated you wanted to know what you were supposed to do and that you were on your way to work. You then stated again you were going to call your son and ended the call.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
