## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible to receive up to \$256.00 per month in advance payments of the premium tax credit, effective April 1, 2017?

Did NY State of Health properly determine that you were eligible for cost-sharing reductions?

Did NY State of Health properly determine that you were not eligible for the Essential Plan?

## Procedural History

On January 31, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with a \$20.00 per month premium for a limited time, effective March 1, 2017. You were asked to submit documentation to confirm the income information in your application.

Also on January 31, 2017, NYSOH issued an enrollment confirmation notice confirming your enrollment in the Essential Plan 1, effective March 1, 2017.

On February 21, 2017 you uploaded copies of your paycheck stubs.

On March 2, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to receive up to \$202.00 per month in advance payments of the

premium tax credit (APTC), effective April 1, 2017. This notice stated that you were not eligible for cost-sharing reductions or the Essential Plan because the income in your application was over the allowable income limit for those programs.

Also on March 2, 2017, NYSOH issued a disenrollment notice stating that your coverage in the Essential Plan 1 would end as of March 31, 2017.

On March 6, 2017, you updated your application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible to receive up to \$256.00 in APTC and eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan for a limited time, effective April 1, 2017.

Also on March 6, 2017, you spoke to NYSOH's Account Review Unit and appealed that preliminary eligibility determination insofar as you were not found eligible for the Essential Plan. That day, you also requested Aid to Continue pending the outcome of your appeal.

On March 7, 2017, NYSOH issued a notice of eligibility determination, based on the March 6, 2017 application, stating that you were eligible to receive up to \$256.00 in APTC and eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan, effective April 1, 2017. This notice requested that you submit income documentation to confirm the income in your NYSOH application. This notice further stated that you were not eligible for the Essential Plan because your income was over the allowable income limit for that program.

On March 14, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan with a \$20.00 premium for a limited time because you had been granted Aid to Continue until a decision was made on your appeal. You were subsequently reenrolled into the Essential Plan.

On June 15, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to June 30, 2017, to allow you to submit supporting documents.

On June 16, 2017, NYSOH Appeals Unit received a 16-page fax containing a copy of your 2016 income tax return. The fax was incorporated into the record as Appellant's [REDACTED]. The record is now closed.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on March 6, 2017 listed annual household income of \$29,297.50, consisting of income you earn from your employment. You testified that this amount was correct.
- 4) You testified that your 2017 expected annual income will be similar to what you received in 2016.
- 5) You provided a copy of your 2016 income tax return that shows an adjusted gross income of \$31,373.00.
- 6) Your application states that you live in [REDACTED]

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

*minus*

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

### Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

## Legal Analysis

The first issue is whether NYSOH properly determined that that you were eligible to receive up to \$256.00 per month in APTC, effective April 1, 2017.

The application that was submitted on March 6, 2017 listed an annual household income of \$29,297.50 and the eligibility determination relied upon that information.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

You reside in [REDACTED], where the second lowest cost silver plan available for an individual through NYSOH costs \$453.55 per month.

An annual income of \$29,297.50 is 246.61% of the 2016 FPL for a one-person household. At 246.61% of the FPL, the expected contribution to the cost of the health insurance premium is 8.09% of income, or \$197.51 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$453.55 per month) minus your expected contribution (\$197.51 per month), which equals \$256.04 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$256.00 per month in APTC.

The second issue is whether NYSOH properly determined that you were eligible for cost-sharing reductions.

Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$29,297.50 is 246.61% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined that you were not eligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$29,297.50 is 246.61% % of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

Since the March 7, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for up to \$256.00 per month in APTC, eligible for cost-sharing reductions, and ineligible for the Essential Plan, it is correct and is AFFIRMED.

## **Decision**

The March 7, 2017 eligibility determination notice is AFFIRMED.

You remain eligible for cost-sharing reductions.

You are not eligible for the Essential Plan.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
