## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid retroactively from November 1, 2016 through November 30, 2016?

## Procedural History

On February 2, 2017, you submitted an application for financial assistance with health insurance and indicated that you were seeking help for paying for medical bills for November 2016.

On February 4, 2017, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan with no monthly premium for a limited time, effective March 1, 2017.

Also on February 4, 2017, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid from November 1, 2016 through November 30, 2016 because the monthly household income you provided of \$1,470.43 is over the allowable monthly income limit of \$1,367.00.

On March 7, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as you were denied retroactive Medicaid for the month of November 2016.

On June 14, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open to June 29, 2017, to allow you to submit supporting documents.

As of June 29, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid from November 1, 2016 through November 30, 2016.
- 2) You testified that you expect to file your 2017 federal income tax return as single, and claim no dependents.
- 3) You submitted an application for financial assistance on February 3, 2017.
- 4) Your application submitted on February 3, 2017, states that for the month of November 2016 your income was \$1,470.43. You testified that amount was incorrect.
- 5) You testified that you are paid on average between \$900.00 to \$1,500.00 per month before taxes.
- 6) The record was held open to June 29, 2017, to allow you to submit supporting documents and no proof of income for November 2016 was received by the NYSOH Appeals Unit.
- 7) Your application states that you do not plan on taking any deductions on your tax return.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). For the month in which you are seeking retroactive Medicaid, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

### Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid from November 1, 2016 through November 30, 2016.

You are in a one-person household for purposes of this analysis because you file your taxes with a tax filing status of single and claim no dependents on your tax return.

You applied for financial assistance on February 3, 2017, and requested help in paying for medical bills for the month of November 2016. You testified that you are seeking Medicaid for the month of November 2016.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not

matter whether that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application. November 2016 was the third month before your February 2, 2017 application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

To be eligible for Medicaid in November 2016, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,367.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during November 2016.

You testified that you are paid between \$900.00 and \$1,500.00 monthly. However, you failed to provide any proof of your income for the month of November 2016. Therefore, the credible evidence of the record indicates, that in the month of November 2016, you had a monthly household income of \$1,470.43.

Since your income of \$1,470.43, as attested to in your application, was more than the \$1,367.00 monthly Medicaid limit for November 2016, NYSOH properly determined that you were not eligible for Medicaid coverage during that month.

Therefore, the February 4, 2017 eligibility determination notice stating that you were not eligible for Medicaid in the month of November 2016, is correct and is AFFIRMED.

## **Decision**

The February 4, 2017 eligibility determination notice is AFFIRMED.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
