NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On February 3, 2017, NY State of Health (NYSOH) issued an eligibility determination notice, stating that you were eligible for a full cost qualified health care plan, effective March 1, 2017. On March 7, 2017 NYSOH advised you that you were not qualified for a special enrollment period in which to change health care plans. You appealed both the February 3, 2017 eligibility determination notice and the March 7, 2017 verbal denial of a special enrollment period.

On July 20, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeals because of the lapse in time you have decided to stay in your bronze-level qualified health plan.

You therefore withdrew both of your appeals on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice, showing good cause as to why the dismissal should be vacated.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
