Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for advance payments of the premium tax credit and cost sharing reductions ended effective April 1, 2017?

Procedural History

On November 27, 2016, NYSOH issued a notice of eligibility determination stating that you were conditionally eligible to receive up to \$314.00 in advance payments of the premium tax credit (APTC) and conditionally eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan, effective January 1, 2017. The notice further directed you to provide documentation confirming your income before February 24, 2017.

On November 27, 2016, NYSOH issued a notice confirming your enrollment in qualified health plan with APTC and cost-sharing reductions for a cost of \$169.44 per month, effective January 1, 2017.

On March 2, 2017, NYSOH issued an eligibility determination notice stating that on March 1, 2017, you were redetermined to be newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to receive APTC or cost-sharing reductions because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective April 1, 2017.

On March 3, 2017, NYSOH issued an enrollment confirmation notice stating that you were enrolled in a qualified health plan with \$0.00 of APTC applied to your premium for a total cost of \$483.44 per month.

On March 3, 2017, you updated your application for financial assistance.

On March 4, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$295.00 in APTC and eligible to receive cost-sharing reductions if you enrolled in a silver level qualified health plan, effective April 1, 2017.

On March 4, 2017, NYSOH issued an enrollment notice stating you were enrolled in a silver level health plan with \$0.00 tax credit per month effective January 1, 2017.

On March 7, 2017, you spoke to NYSOH's Account Review Unit and appealed the termination of your APTC for the month of April, 2017.

On June 22, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of proceeding.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your NYSOH account confirms, that you receive all of your notices from NYSOH by electronic mail.
- 2) You testified that you did not receive any electronic alerts notifying you of any notice in your NYSOH account stating that your eligibility was only conditional and that you needed to provide documentation of your income.
- 3) You testified that you did not know that you needed to submit documentation of your income until late March when you received your bill from your health plan showing it had increased to \$483.44 per month.
- 4) Your NYSOH account indicates that on March 1, 2017 your application was run and you were found no longer eligible for APTC as of April 1, 2017.

- 5) You updated the income information in your NYSOH account on March 3, 2017, and were determined eligible for APTC of up to \$295.00 per month April 1, 2017.
- 6) You testified you have made your premium payments to your health plan for all months, and since April 1, 2017 have been receiving the increased premium bill without the application of APTC or cost sharing reductions.
- 7) You testified that you are seeking reinstatement of your APTC and cost sharing reductions as of April 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for Advance Payments of the Premium Tax Credit

APTC are generally available to a person who is eligible to enroll in a qualified health plan and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a qualified health plan, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

An applicant is required to attest to their household's projected annual income for purposes of determining their eligibility for APTC (45 CFR § 155.320(c)(3)(ii)(B)). For all individual's whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility

based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any changes in eligibility to APTC effective as of the first day of the month following the date of the notice (45 § 155.310(f), 45 CFR § 155.330(e), (f)(1)(i)).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Electronic Notices

Applicants may choose to receive notices and information from NYSOH by either electronic or regular mail. If the individual elects electronic communications, NYSOH must send an email or other electronic communication alerting the individual when a notice has been posted to his or her account and send a notice by regular mail within three business days if the electronic communication cannot be delivered (45 CFR § 155.230(d); 42 CFR § 435.918(b)(4), (5)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for APTC and cost-sharing reductions ended effective April 1, 2017.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking APTC, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on November 27, 2016, you were advised that your eligibility for APTC was only conditional, and that you needed to confirm your household's income before February 24, 2017.

The record reflects that NYSOH did not receive the requested income documentation before the deadline.

However, you testified that you elected to receive alerts regarding notices from NYSOH electronically. You credibly testified that you did not receive any electronic alert regarding the eligibility determination notice, which directed you that your eligibility was only conditional and that you needed to submit documentation to confirm your income.

There is also no evidence in your account documenting that any email alert was sent to you regarding the need to submit documentation, or that the notice was later sent to you by regular mail.

Therefore, it is concluded that NYSOH did not give you the proper notice that you needed to submit documentation of your income in order to confirm your eligibility for APTC.

Since you were not made aware of and did not receive proper notice that there was an inconsistency in your NYSOH account, the March 2, 2017 eligibility determination notice stating that you are no longer eligible for APTC and cost sharing reductions April 1, 2017 because you failed to submit documentation is **RESCINDED**.

When you updated your application on March 3, 2017, you were again found eligible now for an APTC of up to \$295.00 per month and cost sharing reductions effective April 1, 2017. You were enrolled into your same plan but the application of those tax credits and cost sharing reductions were never applied according to the record and your testimony.

Your case is **RETURNED** to NYSOH to reinstate your APTC of \$295.00 and cost sharing reductions eligibility as of April 1, 2017.

Decision

The March 2, 2017 notice of eligibility determination is **RESCINDED**.

Your case is **RETURNED** to NYSOH to reinstate your \$295.00 APTC and cost sharing reductions as of April 1, 2017.

How this Decision Affects Your Eligibility

NYSOH erred in terminating your APTC and cost sharing reductions effective April 1, 2017, without the proper notice.

Your case is being sent back to NYSOH to reinstate your APTC and cost sharing reductions as of April 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
