Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan was effective February 1, 2017?

Procedural History

On December 22, 2016, NYSOH received your updated application for financial assistance.

On December 23, 2016, NYSOH issued a notice of eligibility determination, based on your December 22, 2016 application, stating that you were eligible for Medicaid, effective January 1, 2017.

Also on December 23, 2016, NYSOH issued a notice of enrollment in the plan you selected on February 1, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on February 1, 2017.

On March 8, 2017, NYSOH received your updated application for financial assistance. That day, NYSOH issued a preliminary eligibility determination stating that you were eligible for Medicaid, effective March 1, 2017. That day, you also confirmed your plan selection for a Medicaid Managed Care plan.

Also on March 8, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment your Medicaid Managed Care plan, insofar as it did not begin December 1, 2016.

On March 9, 2017, NYSOH issued a notice of eligibility determination, based on your March 8, 2017 application, stating that you would remain eligible for Medicaid, effective March 1, 2017.

On March 9, 2017, NYSOH issued a notice of enrollment confirmation, stating that you were enrolled in your Medicaid Managed Care plan, effective February 1, 2017.

On June 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- You updated your application to NYSOH for financial assistance to reflect that you were pregnant on December 22, 2016.
- You testified, and the record reflects, that you selected your Medicaid Managed Care Plan on December 22, 2016, and that your enrollment was effective on February 1, 2017.
- 3) You testified that you first learned that you were pregnant on , but did not confirm this with a doctor until .
- 4) You testified that you waited to report your pregnancy to NYSOH until you confirmed this with a doctor.
- You testified that you want your Medicaid Managed Care plan to begin on January 1, 2017 because you received medical treatment in January 2017 that was not covered by Fee-For Service Medicaid.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR §

435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in your Medicaid Managed Care plan was effective February 1, 2017.

You testified that you contacted NYSOH on December 22, 2016 to report your pregnancy, and as a result you were found eligible for Medicaid. You further testified that you selected a Medicaid Managed Care plan for enrollment that day.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On December 22, 2016, you selected a Medicaid Managed Care plan, so it properly took effect on the first day of the second month following after December 2016; that is, on February 1, 2017.

Therefore, the March 9, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan was effective February 1, 2017, was correct and must be AFFIRMED.

Decision

The March 9, 2017 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is February 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
