NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On March 4, 2017, NY State of Health (NYSOH) issued an enrollment notice confirming you and your spouse were enrolled in an Essential Plan, effective April 1, 2017. You appealed the start date of coverage.

On March 23, 2017, NYS Department of Health conducted an override and changed your and your spouse's Essential Plan coverage start date to March 1, 2017.

On April 10, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you and your spouse were given the March 1, 2017 start date that you were seeking on appeal and were satisfied with that start date.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
