## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On February 17, 2017, NY State of Health (NYSOH) issued an enrollment notice, stating that coverage for your youngest child under his Medicaid Managed Care (MMC) plan would begin effective April 1, 2017. You appealed insofar as you were seeking for his MMC plan coverage to begin no later than March 1, 2017.

On June 15, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed your spouse under oath.

While under oath, your spouse identified herself and stated that you were no longer interested in pursuing your appeal because your youngest child's MMC plan coverage backdate request had been approved by NYSOH on or about May 17, 2017, such that the start date of his MMC plan coverage took effect March 1, 2017.

Your spouse, therefore, withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
