## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in an Essential Plan was effective January 1, 2017?

## Procedural History

On December 12, 2016, NYSOH received your application for financial assistance with your health insurance.

On December 13, 2016, NYSOH issued an eligibility determination notice stating that you were eligible for the Essential Plan for a limited time, effective January 1, 2017. The notice directed you to produce income documentation for your household by March 12, 2017.

On December 16, 2016, you faxed income documentation to NYSOH.

On January 12, 2017, NYSOH verified the paystubs you submitted as documentation and a new application was submitted on your behalf.

On January 14, 2017, NYSOH issued an eligibility determination notice was issued finding you eligible for the Essential Plan effective February 1, 2017.

Also on January 14, 2017, an enrollment confirmation notice was issued confirming your enrollment in the Essential Plan, effective January 1, 2017.

On March 9, 2017, you contacted the NYSOH Account Review Unit and requested an appeal of the start date of your Essential Plan, insofar as you were seeking a November 1, 2016 start date.

On June 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that the hearing be adjourned to a later date, and the Hearing Officer agreed to adjourn the hearing to June 21, 2017 at 9:00 a.m.

On June 21, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to July 5, 2017 to allow you time to submit documentation.

On June 29, 2017, NYSOH received your documentation. The record remained open to July 5, 2017, and was closed at end of business that day.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you are appealing your enrollment start date of your Essential Plan coverage.
- 2) According to your NYSOH account, NYSOH received your application for financial assistance on December 12, 2016.
- 3) The record reflects that you enrolled in Essential Plan coverage on December 12, 2016.
- 4) On December 12, 2016, you submitted documentation of your paystubs to NYSOH for verification of the income stated in your December 12, 2016 application.
- 5) On January 12, 2017, your paystubs were verified as acceptable proof of income, and an application was run on your behalf.
- 6) You testified that you want your Essential Plan coverage to begin on November 1, 2016, because you have outstanding bills.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective January 1, 2017.

You testified, and the record indicates, that you updated your NYSOH application on December 12, 2016. As a result, you were found eligible for the Essential Plan for a limited time, as of January 1, 2017 and enrolled into a plan that day. NYSOH subsequently submitted an application on your behalf on January 12, 2017, and issued an enrollment confirmation notice dated January 14, 2017 stating that your enrollment in the Essential Plan was effective January 1, 2017.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On December 12, 2016, you selected an Essential Plan, so your enrollment properly took effect on the first day of the first month following December 2016; that is, on January 1, 2017.

Therefore, the January 14, 2017 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective January 1, 2017, is correct and must be **AFFIRMED**.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
