Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your child's eligibility for and enrollment in a Child Health Plus plan terminated, effective January 31, 2017, and did not resume until March 1, 2017?

Procedural History

On October 15, 2016, your child was added to your NY State of Health (NYSOH) account and an application was submitted on [REDACTED] behalf.

On October 16, 2016, NYSOH issued a notice of eligibility determination stating that your child was conditionally eligible to enroll in Child Health Plus with a \$9.00 per month premium effective November 1, 2016. The notice requested that you provide documentation confirming [REDACTED] citizenship status and Social Security number before January 13, 2017.

Also on October 16, 2016, NYSOH issued a notice confirming your child's enrollment in a Child Health Plus plan, effective November 1, 2016.

No documentation was provided by January 13, 2017.

On January 20, 2017, NYSOH issued an eligibility determination notice stating that your child was not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. [REDACTED] also could not enroll in a qualified health plan at full cost because you had not

confirmed [REDACTED] citizenship status and Social Security number within the required timeframe.

On January 21, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in [REDACTED] Child Health Plus plan would end effective January 31, 2017 because [REDACTED] was no longer eligible to enroll in health insurance through NYSOH.

On January 23, 2017, your child's Social Security number was added to your NYSOH account.

On January 24, 2017, NYSOH issued an eligibility determination notice stating that your child was eligible to enroll in Child Health Plus with a \$9.00 per month premium, effective March 1, 2017.

Also on January 24, 2017, NYSOH issued an enrollment confirmation notice stating that your child was enrolled in a Child Health Plus plan.

On March 9, 2017, you spoke to NYSOH's Account Review Unit and appealed your child's disenrollment from [REDACTED] Child Health Plus plan in the month of February 2017.

On June 21, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your child's disenrollment from [REDACTED] Child Health Plus plan for the month of February 2017.
- 2) The record indicates that your child was added to your NYSOH account on October 15, 2016. The application that was submitted that day indicates that [REDACTED] was a US Citizen but that [REDACTED] did not have a Social Security number; you were in the process of applying for one.
- 3) You testified that you had received your child's Social Security number prior to October 2016, but that you inadvertently did not enter it on the October 15, 2016 application.
- 4) You testified that you paid premiums for your child's Child Health Plus plan for the months of November 2016, December 2016, and January 2017.

- 5) You testified that you did not know your child had been disenrolled from ■ Child Health Plus plan until you contacted your insurance carrier on January 23, 2017 to make a premium payment for February 2017, which they would not accept.
- 6) The record indicates that on January 23, 2017 your child's Social Security number was added to your NYSOH account.
- 7) You testified that you incurred medical bills for your child during February 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (NY PHL) § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(NY PHL § 2511(2)(a)-(e)).

As a condition of eligibility for Child Health Plus, an individual, including children, must furnish their Social Security Number and evidence of their citizenship or status as a qualified immigrant or PRUCOL alien to NY State of Health for verification purposes (42 CFR § 435.910(a) and (b)(3); 42 CFR § 457.340(b); 18 NYCRR § 360-3.2(j)(2) and (3); *see generally* 18 NYCRR § 360-3.2(j)).

NYSOH must require an applicant who has a Social Security Number to provide the number but does not require an applicant's Social Security Number as a condition of enrollment for Child Health Plus if the applicant is not eligible to receive one or his or her number is not yet available (42 CFR § 457.340(b), 42 CFR § 435.910(h)(1); Model State Children's Health Insurance Program Plan, Section 4.1.9).

If an applicant attests to citizenship, status as a national, or lawful presence, and NYSOH is unable to verify such attestation, NY State of Health must then provide the applicant with 90 days to provide satisfactory documentary evidence. Notice is considered received five days after the date on the notice, unless the applicant demonstrates that he or she did not receive the notice within the five-day period (45 CFR § 155.315(c)(3), (f)(2)(i)).

If NYSOH remains unable to verify the citizenship attestation after the 90-day period ends, it must determine the applicant's eligibility based on the information available (45 CFR § 155.315(f)(5)).

NYSOH is required to provide proper written notice to an applicant of any decision effecting an enrollee's Child Health Plus eligibility (42 CFR § 457.340(e)). When Child Health Plus coverage is denied, suspended or terminated NYSOH must provide sufficient notice to enable the child's parent or caretaker relative to take appropriate actions in order to allow Child Health Plus coverage to continue without interruption (42 CFR § 457.340(e)(2); 42 CFR § 457.1130(a)(3)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child's eligibility for and enrollment in Child Health Plus terminated effective January 31, 2017, and did not resume until March 1, 2017.

NYSOH is required to determine whether individuals are eligible to enroll in coverage through NYSOH, and must confirm, among other things, their Social Security number and citizenship status.

If NYSOH cannot verify an individual's citizenship status or Social Security number, it must provide the individual with notice of the inconsistency. NYSOH must then provide the individual with a period of 90 days from the date notice is received to resolve the inconsistency.

The record indicates that your child was added to your NYSOH account on October 15, 2016. The application that was submitted that day indicates that he

was a U.S Citizen but ■ did not have a Social Security number because you were in the process of applying for one.

In the eligibility determination issued on October 16, 2016 you were advised that your child's eligibility for Child Health Plus was only conditional, and that you needed to confirm ■ Social Security number and citizenship status before January 13, 2017.

You testified that you provided your child's Social Security number on January 23, 2017. The record indicates that NYSOH did not have ■ Social Security number before the January 13, 2017 deadline.

On January 21, 2017, NYSOH issued a disenrollment notice stating that your child's coverage in ■ Child Health Plus plan would end effective January 31, 2017 because ■ was no longer eligible to enroll in health insurance through NYSOH. According to the eligibility determination issued on January 20, 2017, this was because NYSOH had not received documentation of ■ citizenship status and Social Security number.

When NYSOH denies, terminates, or suspends a child's Child Health Plus coverage, they are required to provide sufficient notice so that a child's parent is able to take action to prevent a gap in coverage for the child. Notice is considered received five days after the date on the notice. In this case, the notice formally disenrolling your child from ■ Child Health Plus plan was dated January 21, 2017. Therefore, the notice terminating your child's enrollment would be considered received as of January 26, 2017.

When changes are made to an individual's application after the 15th of any month, NYSOH must make the redetermination that results from a change effective the first day of the next following month. Since you would have received NYSOH's notice terminating your child's Child Health Plus eligibility after the 15th of the month, any changes you would have made to your account to prevent a gap in coverage would not have been effective until March 1, 2017.

Therefore, NYSOH failed to provide you with sufficient notice that would have allowed you to take action in order to prevent a gap in Child Health Plus coverage for your child for the month of February 2017 and the January 20, 2017 eligibility determination notice and January 21, 2017 disenrollment notice are RESCINDED.

Decision

The January 20, 2017 eligibility determination notice and January 21, 2017 disenrollment notice are RESCINDED.

How this Decision Affects Your Eligibility

Your child should not have been terminated from ■ Child Health Plus plan in February 2017 for failure to submit proof of ■ citizenship status and Social Security number.

Your case is being sent back to NYSOH to reinstate your child into ■ Child Health Plus for the month of February 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
